This response ("Response") to the Office Action issued on June 4, 2019 ("Office Action"), regarding the application by Polymath Inc. ("Applicant") for registration of the trademark STO ("Mark"), U.S. Trademark Serial No. 88/019,801 in Classes 35, 36, 41 and 42 ("Application") addresses the issue raised by the Examining Attorney ("Examiner"). Based on responses to the issues in this Response, Applicant respectfully requests that the Examiner approve the Application to proceed to publication on the Principal Register.

## Amendment to Services

Applicant requests amendment to the services as follows:

Class 35: Business research in the fields of cryptography, cryptocurrency, cryptosecurities **and** digital assets and digital currency

(Applicant requests to delete entire class) Class 36: Financial consultation in the field of cryptocurrency, namely, advising in the field of the creation and launch of cryptographic/digital assets over the Internet; Provision of information and data in the field of cryptocurrency concerning cryptographic/digital asset creation; Providing financial information in the field of cryptocurrency and cryptosecurities online and through trade shows, blogs, conventions, websites, sessions and panels, 1x1 meetings, and keynote dinners

Class 41: Arranging and conducting educational conferences; Arranging of seminars; Providing live and online classes, seminars, and workshops in the fields of technology, <del>cryptocurrency, crypto tokens,</del> and crypto securities

Class 42: Computer software development, namely, development of a software platform used by others to conduct securities offerings and initial coin offerings (ICO); Providing online nondownloadable software for development of a platform used by others to conduct securities offerings and initial coin offerings (ICO); IT consulting services; IT consulting services in the field of <del>cryptography, cryptocurrency</del>, cryptosecurities, and digital currency; Technical support services, namely, troubleshooting of computer software problems; technical support services, namely, troubleshooting of software platforms for conducting securities offerings; Research and development of technology in the fields of <del>cryptography, cryptocurrency</del>, cryptosecurities **and** digital assets <del>and digital currency</del>

## **Requirement for Information**

Pursuant to the Examiner's request, Applicant submits the following information:

(1) STO is an acronym for the wording Securities Token Offering. Applicant's services are provided in the fields of cryptosecurity and digital assets.

- (2) Response to the following questions:
- \* Does the acronym "STO" stand for "Security Token Offering" and/or "Securities Token Offering"?

Yes, both interchangeably.

- \* Are "securities tokens" a type of cryptocurrency or cryptosecurity? Applicant's mark, SECURITIES TOKEN, is used with services relating to cryptosecurities and digital assets, which are representations of shares on the blockchain. That is, rather than having a paper share certificate to represent ownership of shares in a company, the holder has a digital representation of the shares that reside on the blockchain, and applicant's services are provided in connection therewith.
- \* Are "securities tokens" a type of digital asset or digital currency? Applicant's mark is used with services relating to cryptosecurities and digital assets, as discussed above.
- Does applicant provide financial consultation or financial information in the field of securities tokens?
  No. Applicant has amended the description of services offered under Applicant's mark to clarify.
- \* Does applicant provide conferences, seminars and classes in the field of securities tokens? Applicant provides conferences, seminars and classes in the fields of technology and cryptosecurities.
- \* Does applicant provide computer software in the field of securities tokens?

Applicant provides computer software to conduct securities offerings and initial coin offerings in the fields of cryptosecurity and digital assets.

- \* Does applicant develop computer software in the field of securities tokens? Applicant develops computer software to conduct securities offerings and initial coin offerings in the fields of cryptosecurity and digital assets.
- \* Does applicant provide technical support for software in the field of securities tokens? Applicant provides technical support in the form of troubleshooting of software platforms for conducting securities offerings.
- Does applicant provide research and development of technology in the field of securities tokens?
  Applicant provides research and development of technology in the fields of cryptosecurity and digital assets.

## **Conclusion**
