# **Applicant's Response to Office Action - Serial No. 88119543**

## I. Amendment of Description of Services

Applicant Sacred Treasure House, Inc. humbly requests leave to amend the description of services to the following:

Educational services, namely, providing classes, seminars, workshops, and presentations in the field of cannabis; Organizing events in the field of cannabis for educational purposes; Entertainment services, namely, the provision of continuing programs, segments, on-line non-downloadable videos and articles in the field of cannabis delivered by internet and other multimedia platforms; Entertainment services, namely, live presentations of lectures and panel discussions in the field of cannabis.

Applicant specifically authorizes the services identification amendment listed above.

#### **II. Single Class Application**

Applicant humbly requests leave to amend the identification of goods and services to identify a single international class (International Class 41), and specifically authorizes this amendment.

### III. Mark Differs on Drawing & Specimen - Request to Amend Filing Basis

Applicant humbly requests leave to amend the filing basis from "In Use" to "Intent-to-Use" under Section 1(b). Applicant has a bona fide intent to use the "SWAMI" mark in commerce for the above-mentioned services as of the filing date. Applicant will provide a specimen of the "SWAMI" mark once Applicant begins using that mark in interstate commerce.

Applicant specifically authorizes this filing basis amendment.

# IV. Additional Information about Goods and Services

The services identified in the application comply with the Controlled Substances Act (CSA). The services identified in the application are educational and entertainment services which do not involve manufacturing, distributing, dispensing, or possessing marijuana or any other controlled substance; nor do they involve the sale, offer for sale, or use of any facility of interstate commerce to transport drug paraphernalia. Education and entertainment related to cannabis would be provided without violating the CSA. Although no fact sheets, brochures, or similar

materials about the services identified in the application have yet been created, once they are they will be provided to the USPTO.

In response to the Examiner's questions:

- 1. None of Applicant's identified services include or involve, nor will they include or involve, the sale, manufacture, distribution, delivery, dispensing, possession, or provision of marijuiana, marijuana-based preparations, extracts or derivatives from marijuana, synthetic marijuana, or any other controlled substance under the CSA.
- 2. Applicant's identified services do not include or involve the sale, manufacture, distribution, delivery, dispensing, possession, or provision of hemp, hemp-based preparations, extracts or derivatives from hemp.
- 3. None of Applicant's identified services include or involve the sale, manufacture, distribution, delivery, dispensing, possession, or provision of goods primarily intended or designed for use with marijuana, marijuana-based preparations, extracts or derivatives from marijuana, synthetic nmarijuana, or any other controlled substance under the CSA.
- 4. Upon information and belief, Applicant's identified services comply with the Controlled Substances Act
