In an Office Action dated September 16, 2014, the Examiner raised the following issues:

- 1) Likelihood of Confusion
- 2) Disclaimer

In response, Applicant states the following:

I. Likelihood of Confusion

The Examiner indicates that a prior registration creates a likelihood of confusion with the applied-for mark and has therefore refused registration pursuant to 15 USC 1052(d). Applicant respectfully traverses this refusal.

Analysis of a likelihood of confusion tends to involve several factors:

- The similarity of the marks in their entirety as to appearance, sound, connotation, and commercial impression;
- The relatedness of the goods and services;
- The similarity or dissimilarity of established, likely-to-continue trade channels;
- Sales conditions (i.e. “impulse” v. careful purchasing);
- Number and nature of similar marks in use with similar services; and
- Existence of a valid consent agreement.

TMEP §1207.01. Several of these factors will be discussed below.

US Registration 4,372,072 – LEGENDS

The mark cited by the Examiner is for “LEGENDS” in standard characters, used in association with “Arrows; Toy bows and arrows; Toy weapons,” in IC 028.

1) Similarity of the Marks

The applied-for mark is “LEGEND ULTRA-LITE” with “ULTRA-LITE” disclaimed (see below). The cited mark is “LEGENDS.” The Examiner indicates that the marks are nearly identical, however the Examiner completely disregards the terms “Ultra-Lite” when making a comparison. The Examiner correctly states that a comparison should not be made side-by-side but instead it should be determined if the marks are sufficiently similar *in their entirety* (emphasis added). See TMEP § 1207.01(b). The Examiner then proceeds to compare only the term “LEGEND” with the cited mark. Although the disclaimed terms are typically given less weight, they cannot be completely ignored when making a comparison, as the Examiner here appears to do. Instead, when comparing the marks in their entirety, the additional terms “Ultra-Lite” give the applied-for mark and the cited mark distinctly different commercial impressions. See TMEP § 1207.01(b)(iii).

Therefore, this factor points away from a likelihood of confusion.

2) Channels of Trade

The applied-for mark is used in connection with “crossbows” in IC 028. These crossbows are offered for sale in sporting goods stores, hunting specialty shops, gun stores, and on internet sites devoted to similar pursuits (e.g. sporting goods, hunting, firearms etc...).

The owner of the cited mark manufactures toys, specifically toy bows and toy arrows. These products are marketed and sold in places one would typically find toys, e.g. toy stores, big box retail stores, and related internet sites.

Buyers of crossbows are not likely to seek the applicant’s goods in a toy store just as toy buyers are not likely to look for toys in a hunting lodge. Thus the channels or trade are not similar and are likely to remain separate in the future

This factor points away from any likelihood of confusion.

3) Sale Conditions

As discussed above, a would-be purchaser of the applicant’s goods are not likely to seek out a hunting crossbow in a toy store. Instead, a crossbow consumer would seek out these products in a sporting goods or hunting specialty store. The purchase of a crossbow is not something they would take lightly as well, for a number of reasons: 1) a crossbow can be a deadly instrument if not handled properly; 2) crossbows are expensive, ranging in price from a few hundred dollars up to thousands of dollars; 3) crossbow use for hunting is regulated, or prohibited, in all 50 states (See Tenpoint US Regulations – attached as Exhibit A and incorporated herein); and 4) crossbows vary widely in features such as draw weight (which is a measurement of the strength needed to pull back the bow string), size, firing speed and compatible accessories. A crossbow consumer is likely to research the proper size and draw weight as well as consider the available accessories before making a purchase of a crossbow.

On the other hand, the typical purchaser of a toy bow and arrow set is either a young child, or a parent buying for a child. These classes of consumers are not likely to spend considerable, if any significant, amount of time considering the features of a toy bow and arrow set. Similarly, the cost of a toy bow and arrow set is under \$25, which would make it more of an impulse purchase than would be a crossbow purchase.

A consumer coming across a \$25 tow bow and arrow is not likely to believe that it emanates from the same source as a \$300-\$2000 hunting weapon just as a consumer coming across a crossbow is not likely to be confusing into thinking it was made by a toy manufacturer. Therefore, this factor points away from any likelihood of confusion as well.

4) Similarity of the Goods

As discussed above, the applied-for mark is used with crossbows, while the cited mark is used in association with toy bows and toy arrows. Screenshots of the registration owner’s website are attached hereto and incorporated herein as Exhibit B. As seen in Exhibit B, the cited mark is used on two models of toys offered by the registration owner. A consumer is unlikely to believe that these toys are produced by the same company that produces Applicant’s crossbows, just as consumer is unlikely to believe that Applicant also produces these toys.

Applicant understands that the broad term “arrows” in the cited mark’s recitation of goods may be construed to include crossbow arrows, however, Applicant respectfully disagrees that this is enough

for a likelihood of confusion. Furthermore, Applicant respectfully disagrees that the Examiner's cited evidence is relevant or that it shows what the Examiner purports it to show.

The Examiner argues that the term "arrows" in the cited mark's recitation of goods may include crossbow bolts, which are related to crossbows, which is therefore sufficient that a consumer would believe that the source of such crossbow bolts may also be the source of a crossbow bearing a similar mark. In support of this argument, the Examiner cites, in the form of attachments, screenshots of third party websites where one can purchase crossbow bolts.

Applicant respectfully disagrees that the term "arrows" as listed in the cited mark's recitation of goods should be interpreted so broadly. The term "arrows" in the cited recitation of goods, is unclear and undefined when viewed removed from the remainder of the recitation of goods. Simply put, it does not give any instruction as to what type of arrows. The definition of arrow, given by Merriam-Webster online dictionary (<http://www.merriam-webster.com/dictionary/arrow> - last accessed on January 20, 2015), includes both "1: a missile shot from a bow and usually having a slender shaft, a pointed head, and feathers at the butt; and 2: something shaped like an arrow; *especially* : a mark (as on a map or signboard) to indicate direction."

Thus, as the definition includes anything shaped like an arrow, it is necessary to use the context of the remaining recitation of goods to determine the scope of protection. In this case, the remaining listing of goods is "toy bows and arrows; toy weapons." A person in the toy industry would not likely view this description of goods to believe that a toy manufacturer also makes archery or hunting supplies. *See In re Trackmobile Inc.*, 15 USPQ2d 1152, 1154 (TTAB 1990) (noting that, "when the description of goods for a cited registration is somewhat unclear . . . it is improper to simply consider that description in a vacuum and attach all possible interpretations to it when the applicant has presented extrinsic evidence showing that the description of goods has a specific meaning to members of the trade.")

Furthermore, in light of the above, the Examiner's evidence merely shows that a) crossbows use arrows and b) third party sellers sell crossbow arrows. Nowhere on the cited websites are there any arrows bearing the "LEGEND ULTRA-LITE" mark, the "LEGENDS" mark, or any similar mark. Thus a person encountering the cited websites would not likely be confused into thinking the source of the arrows available for sale on such sites is a toy manufacturer.

This factor points away from a likelihood of confusion as well.

II. Disclaimer

Applicant hereby enters the following disclaimer:

"No claim is made to the exclusive right to use "Ultralight" apart from the mark as shown."

III. Conclusion

Having hereby responded to each outstanding issue raised in the Office Action dated September 16, 2014, Applicant hereby requests that application number 86/295,670 be approved for registration.

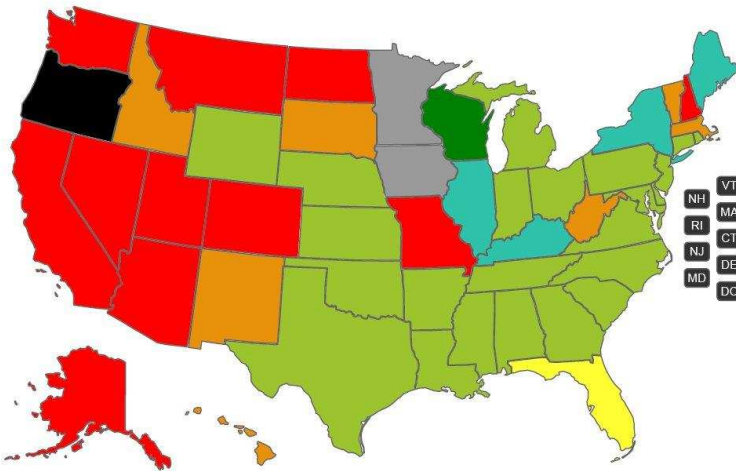

A legally permitted archery hunter may use a crossbow from the second Monday following Thanksgiving through the end of the archery hunting seasons also certain disabled persons with a special crossbow permit or persons 62 years of age or older with photo ID can hunt with crossbows. These individuals may hunt game species with crossbows during seasons allowing the use of archery equipment. Crossbows used in hunting as authorized by a permit issued under this section shall meet all of the following specifications:

- 1) Shall have a minimum peak draw weight of 125 pounds and a maximum peak draw weight of 200 pounds.
- 2) Shall have a minimum overall length (from butt of stock to front of limbs) of 24 inches.
- 3) Shall have a working safety.
- 4) Shall be used with bolts or arrows of not less than 14 inches in length (not including point) with a broadhead. Broadheads may have fixed or expandable blades, but they must be barbless and have a minimum 7/8 inch diameter when fully opened. Broadheads with fixed blade must be metal or flint-, chert-, or obsidian-napped. Broadheads with expandable blades must be metal.

Crossbows are now Approved for use by all archery hunters during the Archery deer season provided the hunter has successfully completed the Bow Hunter education course or otherwise qualifies for an Archery deer permit.

The use of crossbow for hunting wild turkey or any wild bird is prohibited by law (RIGL 20-14-7).

Special permits are no longer required to hunt with the crossbow including those previously required for disabled hunters; however, use of Adaptive Aids for archery hunting still requires the special permit.
