

**M (Serial No. 88501227)**

Applicant responds to the examining attorney's requests for information and documentation with the following written responses and the accompanying evidence:

**(1) Identify the particular good(s) listed in the application for which the specimen(s) was submitted to show use of the mark.**

T-shirts, Polo shirts, and Pants

**(2) Was the specimen created for submission with this application? If so, specify the date each specimen was created. If applicant obtained the image(s) of the goods shown in the specimen(s) from a third-party website, provide the URL of the website and a digital copy of relevant webpage(s) for each image.**

No, the specimens were not created for submission with the application. .

The goods with the mark are displayed and available for sale on shelves and on racks in said store, as shown in photographs annexed hereto.

Applicant's goods were for the first purchased and exported to the United States market on March 19, 2019. The goods are still available for sale to and within the United States in the same environment specified in response to questions (3). The goods bearing the mark were first available for retail purchase within the United States on June 18, 2019.

**(6) For the goods identified in response to question (1), specify the dollar amount of sales with or within the United States and provide at least three invoices or other supporting documentation that show payments or other consideration made, redacting personal or private information of buyers as necessary.**

For the goods identified in response to question (1), the amount of sales with and within the United States is approximately \$300,000.00. This is applicant's best estimate of its sales of the one branded garment it submitted as its original specimen of use. Applicant's goods are sold as a set, based on a general purchase order, not garment by garment.
