The BeVeg Vegan Certification Process

Applications are accepted worldwide in more than 70 countries.

Companies that carry the **BeVeg** Vegan Symbol certification trademark on their products represent their practices are in alignment with the BeVeg vegan definition and standard.

No animal ingredients or animal by-products used in the processing, clarification, filtration, de-acidification, or manufacturing before bottling or packaging. This includes disclosures for all incidental ingredients, natural flavorings and natural colorings. If Sugar is used, proof that the manufacturer uses zero bone char (often disguised as “natural charcoal”) is required. Likewise, source ingredient manufacturers to listed parent ingredients are also investigated to ensure they are maintained. BeVeg attorneys also ask and investigate if the manufacturing, bottling and packaging is from a shared facility that is licensed to a facility that may compromise the vegan status. No animal testing on the BeVeg certification process.

BeVeg attorneys require companies and products to be forthcoming with ingredients, suppliers, and processes in order to maintain integrity with use of the BeVeg vegan symbol.

BeVeg certifies individual products, not companies, however, that does not preclude an entire company from being certified vegan by BeVeg. In such instances, bulk certification discounts are available upon special request and consideration.

Once the application process begins, BeVeg attorneys will review the paperwork, follow up as necessary, conduct due diligence research, gather the necessary third party disclosures and affidavits, and oversee the certification deliberations process. BeVeg, as a law group, with global reach, strives to bring credibility, uniformity, and transparency to vegan claims worldwide.

Testing and analysis will be done by an ISO certified lab as required by the BeVeg certification scheme. Likewise, on-site audits may also be demanded.

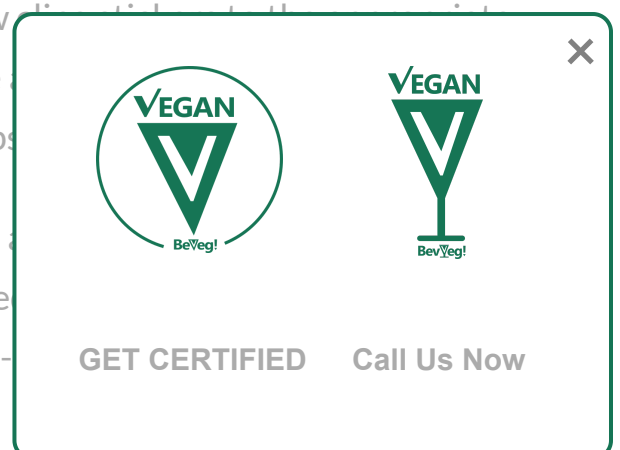
Vegan Certification Process Overview

BeVeg is a law firm, and therefore, we do not have a form application to download. Once the \$100.00 initial fee is paid, to begin the vegan certification process, we ask a series of questions about ingredients, processes, animal testing, shared machinery, and chances for cross-contamination. Once we gather the initial documents, we engage in our cross-examination process to ensure all suppliers and source ingredients maintain the BeVeg vegan standard. Then, we get legal statements and affidavits certifying same. Upon final receipt of all paperwork, we begin certification deliberations where products are reviewed and considered for BeVeg vegan certification.

Once a company passed BeVeg vegan certification, they are sent over a summary of all the findings and a contract to sign outlining vegan logo use guidelines and accompanying affidavits. After the products pass the certification process, the company will pay the annual certification fee.

If approved, BeVeg International will license use of the BeVeg vegan certification symbol for a 12 month period. Among other things, BeVeg will issue a high definition version of the appropriate BeVeg vegan symbol, add the products to the appropriate BeVeg vegan directory, mail BeVeg certified window stickers to the certified company, do extensive social media posts, and issue press releases. We also require for each company to have on file or put on their website:

While we are happy to sign an NDA (non-disclosure agreement) if you do not feel this is necessary, since any trade secrets used in the process are handled by attorneys, which arguably gives rise to the attorney-client



The BeVeg vegan logo licensing fee is per product, however, companies with multiple products can qualify for a bulk discount, or hardship. BeVeg, as a law firm, is almost pro bono in nature. Attorneys and staff are passion driven, rather than profit driven. The mission is a uniform vegan standard that's credible and honest for the consumer.

The BeVeg vegan certification mark color may vary to compliment product packaging.
