Accordingly, please amend the descriptions of goods and services to read:

International Class 011:

Heating and cooling systems comprised of heating installations and cooling apparatus and components and parts therefor sold as a unit; Heating ventilation and air conditioning units, namely, furnaces and heat pumps; residential and commercial ventilating fans; and sStructural component parts thereof; Residential and commercial air conditioning units and; cComponents and accessories thereof, namely, electronic air cleaners, humidifiers, heat recovery ventilators, zoning units, fan coils, evaporator coils and condenser coils; Air handlers in the nature of cabinets housing air blowers; Air handlers in the nature of cabinets housing heat exchangers; Dehumidifiers; Air purifiers; Heat transfer packaged systems for temperature conditioning of buildings comprising both air heating and air cooling units, all for residential and industrial use.

International Class 035:

Wholesale distributorships in the field of heating and cooling systems; Distributorship services in the field of heating and cooling systems; Distributorship services in the field of heating and cooling systems, equipment, and parts thereof; Wholesale store services in the field of heating and cooling systems, equipment and parts thereof; Wholesale distributorships featuring heating ventilation and air conditioning units and parts and accessories related thereto.
