

Office Action Response

The Examiner has requested the following amendment in Class 41:

... Online journals in the nature of blogs on the topics of general human interest, namely [applicant must indicate the field, i.e. fashion tips, places to vacation, etc.]; ...

Applicant respectfully asserts that this clause is sufficiently definite as written and that the above amendment is not required. Specifically, the Trademark ID Manual lists the following acceptable identification of goods:



(full screenshot attached as Attachment A).

Given that the above description of goods is acceptable, there is no reason why Applicant's Class 41 service requires more specificity. An online journal in the nature of a blog is not meaningfully different from printed magazines nor newsletters; it is merely the electronic version of the printed publication identified in the Class 16 product listed in the ID Manual. All are mediums for conveying creative content, including writings, photographs and images. Since printed magazines and newsletters may be in the field of "general human interest," so too may online journals in the nature of a blog.

Indeed, there are a number of registrations that include "general human interest" as a field for online journals, including registrations that issued recently. These include the following:


