RESPONSE TO OFFICE ACTION

Meta Platforms, Inc. ("Applicant") has received and reviewed the Non-Final Office Action issued on July 7, 2022, regarding U.S. Trademark Serial No. 97/202,620 (the "Application") for the mark META ("Applicant's Mark"), with respect to Class 36. Applicant respectfully submits the following response.

I. AMENDMENT OF APPLICANT'S SERVICES

In response to the Examining Attorney's request to clarify certain services in the Application, Applicant has submitted its amendments with this response. Attached as Exhibit A are the final services, as amended.

II. THE ADVISORY REGARDING THE REFERENCED APPLICATIONS MUST BE WITHDRAWN BECAUSE APPLICANT'S PRIORITY CLAIM MUST BE CONSIDERED

The prior-filed application advisory citing U.S. Trademark Application Nos. 97/149,980; 97/131,049; 97/197,141; 97/110,888; 97/108,279 and 97/098,618 (collectively, the "Referenced Applications") must be withdrawn because the subject application (U.S. App. No. 97/202,620) for META was filed with a priority claim that predates the Referenced Applications. Specifically, the Application was filed with a §44(d) claim of priority, relying on Jamaica Trademark Application

No. 083739, which was filed on July 8, 2021. Additionally, U.S. Trademark Application No. 97/131,049 has lapsed.

When an applicant is entitled to priority based on a foreign application, the effective filing date is the date on which the foreign application was first filed in the foreign country. 15 U.S.C. §§1126(d)(1), Trademark Manual of Examining Procedure § 206.02. As detailed in the below table, the Referenced Applications were filed months after the priority date of the Application:

Further, none of the Referenced Applications claim a priority date that is earlier than their respective filing dates. Due to its priority claim, the Application must be afforded priority filing rights as of July 8, 2021, which is the same as the filing date of the original Jamaican priority application. As a result, the advisory regarding the Referenced Applications must be withdrawn and the Application approved for publication.

Applicant reserves its rights to present arguments in support of registration by addressing the issue of potential conflict between Applicant's Mark and the marks in the Referenced Applications, as necessary.

Applicant has addressed all outstanding issues raised by the Examining Attorney.

Accordingly, Applicant respectfully requests the Application be approved for publication.
