

RESPONSE TO OFFICE ACTION

Applicant RH US, LLC hereby responds to the United States Patent and Trademark Office (“USPTO”) Action dated June 29, 2023 (“Office Action”). In the Office Action, the Examining Attorney (“Examiner”) refuses registration of Applicant’s THE WORLD OF RH mark for “furniture; outdoor furniture; beds; chairs; divans; sofas; chests of drawers; love seat; nightstands; sofa beds; dressing tables; tea table; chaise lounges; benches; seats; armchairs; dining chairs; bean bag sofa; deck chairs; tables; side table; console tables; dining tables; folding tables; bookcases; cabinets; desks; sideboards; showcases; footstools; stools; racks; furniture shelves; tv stand; speakers stand (furnitures); portable desks; cabinets of metal; cots; flower-pot pedestals; furniture for houses, offices and gardens; covers for clothing; wall-mounted baby changing platforms; baby diaper replacement table; bassinets; wardrobes; shelves for storage; display stands; towel stands; clothes hangers; magazine racks; luggage shelves(furniture); wine racks; show shelves; step stools, not of metal; decorative mirrors; mirrors; picture frames; works of art of wood, wax, plaster or plastic; tailors' dummies; resin craftwork; works of art made of wood; display boards; wood ribbon; cushions; pillows; bolsters; mattresses; bedding, except linen; cushions furniture; reusable baby changing mats; sleeping mats; curtain rings; indoor window shades; curtain holders, not of textile material; curtain rollers; curtain rails; curtain rods; curtain hooks; curtain tie-backs; bins, not of metal; bamboo, unworked or semi-worked; decorations of plastic for foodstuffs; birdhouses; identification bracelets, not of metal; coffins; furniture, namely, couches, ottomans, daybeds, cribs, dressers, lounge chairs, side chairs, coffee tables, occasional tables, armoires, hutches, media cabinets, file cabinets, tables having the appearance of traveling trunks; furniture, namely, modular seating in the nature of seating furniture; custom furniture; fitted fabric furniture covers; floor pillows; bed pillows; mattress toppers, namely, feather beds; box springs; mattress adjustable bases; kneelers for gardening; bathroom furniture, namely, cabinets, washstands, medicine cabinets and cupboards, shelving, bathroom vanities, etageres, bath stools, bath carts, shower curtain rods; drapery hardware, namely, curtain rods curtain hooks and finials; decorative boxes made of wood; wood garden and household ornaments; decorative wood panels; cast resin garden and household ornaments; screens for fireplaces” in Class 20 (“Applicant’s Mark”). The Examiner requests clarification of the goods.

Applicant agrees to clarify and amend its identification of goods as follows:

display boards; wood ribbon, **namely, composite panels, particle board and fiberboard for use in further manufacturing**; cushions; pillows; bolsters; mattresses; bedding, except linen, **namely, bed headboards, bed frames, and bed risers**; cushions **for** furniture; reusable baby changing mats; sleeping mats; curtain rings; indoor window shades; curtain holders, not of textile material; curtain rollers; curtain rails; curtain rods; curtain hooks; curtain tie-backs **in the nature of non-textile curtain holders**; bins, not of metal; bamboo, unworked or semi-worked; decorations of plastic for foodstuffs; birdhouses; **Non-metal** identification bracelets; coffins; furniture, namely, couches, ottomans, daybeds **being sofas**, cribs, dressers, lounge chairs, side chairs **being dining chairs**, coffee tables, occasional tables, armoires, hutches, media cabinets, file cabinets, tables having the appearance of traveling trunks; furniture, namely, modular seating in the nature of seating furniture; custom furniture; fitted fabric furniture covers; floor pillows; bed pillows; mattress toppers, namely, feather beds; box springs; **adjustable mattress** bases **being adjustable beds**; kneelers for gardening; bathroom furniture, namely, cabinets, washstands, medicine cabinets and cupboards, shelving, bathroom vanities, etageres, bath stools, bath carts, shower curtain rods; drapery hardware, namely, curtain rods, curtain hooks, and finials; decorative boxes made of wood; wood garden and household ornaments; **works of art in the nature of** decorative wood panels **for floors and walls**; cast resin garden and household ornaments; screens for fireplaces

As a result, Applicant believes all outstanding issues with respect to the application for the subject mark have been resolved and respectfully requests approval of the same for publication.
