### **Trademark registration certificate of the Republic of Latvia**

This trademark has registered according to 16th June 1999 Law on Trademarks and Geographical Indications.

Exclusive rights to a registered trade mark, including exclusive rights in relation to other persons, shall be effective to the full extent from the date of publication of the notice of the registration of the trade mark - Law on Trademarks and Geographical Indications 4 (12).

The registration of a trade mark is valid for a period of 10 years from the filing date, if it is not cancelled at the initiative of the owner of the trade mark - Law on Trademarks and Geographical Indications 21 (1).

The registration may, every 10 years, be renewed (the trade mark re-registered) for another 10-year period. The owner of the trade mark shall submit a request for renewal of registration within the last year of validity of the trade mark registration, paying the prescribed fee - Law on Trademarks and Geographical Indications 21 (2).

The trade mark owner shall immediately notify the Patent Office of any amendments or of mistakes discovered in the information concerning the registration of the trade mark, of changes in the owner's name (designation), of a change of representative, of a desire to eliminate goods or services from the list of goods and services, or of a desire to change non-essential (secondary) elements in the trade mark itself - Law on Trademarks and Geographical Indications 17 (2).
