Re: Letter of Consent to Application Serial No. 87/116434 for the mark Discovery Plus Globe Design (B&W) owned by Discovery Communications, LLC.

Dear Sir or Madam:

We, Jaguar Land Rover Limited, are the owner of U.S. Application Serial No. 79/177962 for the mark DISCOVERY in connection with goods set forth below in International Classes 6, 9, 14, 16, 18, 20, 21, 25.

We understand that Discovery Communications, LLC has filed for registration of the mark under Application Serial No. 87/116434, in connection with "Backpacks," in Class 18.

The PTO has refused registration of the DISCOVERY Plus Globe Design (B&W) mark because of an alleged likelihood of confusion with DISCOVERY.

The parties entered into an agreement effective February 21, 2000, by which the parties agreed to cooperate with one another for the purpose of avoiding any instances of actual confusion between the marks that may arise in the future.

Jaguar Land Rover Limited and Applicant believe that the coexistence of these marks in the United States is not likely to create confusion in view of the following:

- the parties have peacefully coexisted with one another since the signing of the referenced agreement;
- neither party is aware of any instances of confusion between DISCOVERY Plus Globe Design (B&W) and DISCOVERY by our respective customers; and
- Jaguar Land Rover Limited and Discovery agreed to use their marks in the automobile field and entertainment/broadcasting fields, respectively.

Class 16: Printed matter and printed publications, namely, travel guide books and books, periodicals, magazines and newspapers featuring information about automobiles and the automotive industry; stationery; posters; paper and printed emblems; maps; office requisites other than furniture, namely, staplers, staple removers, adhesive tape dispensers and rubber bands; printed instructional and teaching materials featuring information about automotive repair; paper; drink mats, namely, cardboard coasters for drinks; photographs; calendars; stickers; paper labels; decalcomanias; drawing and ungraduated rulers; postcards; bookmarks; bookends; erasers; paperweights; book covers; diaries, notebooks, appointment books, address books and combinations of such goods and covers therefor; check book covers; passport covers and holders; folders, holders and covers, all intended for or containing notebooks, notepads, paper, pens, pencils, and/or erasers; art prints on canvas; document holders; towels, napkins, serviettes, mats, coasters, handkerchiefs, tissues, table cloths, absorbent disposable wipes not impregnated with chemicals or compounds, and sanitary and hygienic materials in the nature of toilet tissue and hygienic paper, all made wholly or principally of paper and/or paper derivatives; wrapping and packing materials made wholly or principally of paper or plastics, namely, plastic film for wrapping, plastic bags for packing, and paper for wrapping and packing; plastic cling film for wrapping food; bags, sacks, and disposable covers all made wholly or principally of paper and/or plastic film or sheet materials, namely, paper bags and sacks, plastic shopping bags and sacks, disposable unfitted paper furniture covers, and disposable plastic notebook covers; disposable paper protectors for carpets and seats; unfitted, general purpose sheet materials made wholly or principally of paper and/or paper derivatives for protecting, preserving and/or for

storage purposes; money clips; desk sets comprised of holders for paper and writing instruments; desktop organizers; writing and drawing instruments; writing and drawing materials, namely, pads and paper; document holders

Class 18: Leather and imitation leather bags; leather goods and goods made of imitation leather, namely, duffle bags, tote bags, vanity cases sold empty, all-purpose carrying bags and travelling bags; suitcases; briefcases; attaché cases; luggage; wallets; duffle bags; purses; handbags; parasols; umbrellas; canvas shopping bags; walking sticks; rucksacks; business card holders in the nature of card cases

Class 20: Non-metal locks; plastic card keys, not encoded and not magnetic; plastic key rings; plastic name badges; inflatable plastic signs; nameplates, not of metal; clothes bars for closets, picture and mirror hangers, hooks, and sign holders; baskets for transporting goods for industrial purposes; non-metal bins; racks and racking, namely, display racks; display stands; baby changing platforms; plastic storage containers for commercial or industrial use; plastic security boxes for money; plastic fasteners and fixings, namely, screws, nuts, bolts, washers being hardware; replacement parts and fittings for dispensers for facial tissue, plastic storage containers for commercial use, and baby changing platforms; badges of plastic for use on vehicles; clothes hangers and mannequins; sleeping bags for camping, sleeping mats; non-metal money boxes

Class 21: crockery, namely, pots, dishes, drinking cups and saucers, excluding drinking vessels for animals, bowls, serving bowls and trays; mugs, tankards, napkin holders and rings; serving trays; baking mats; bottle and can openers, corkscrews, plastic coasters; ornaments of crystal and porcelain; combs, hair brushes; small domestic utensils, namely, spatulas, turners and kitchen tongs; small domestic containers for foods; beverage glassware; dinnerware of porcelain and earthenware; tableware, namely, plates, bowls and serving platters; money boxes made wholly or principally of glass, porcelain or earthenware; portable coolers and flasks, all for foodstuffs and/or beverages; espresso sets comprised of cups and saucers; ice cube molds
