**RESPONSE TO SUSPENSION INQUIRY**

This paper is filed in response to the Suspension Inquiry issued in this application on 13 March 2018.

The following issues were raised in the Suspension Inquiry:

- Status of corresponding foreign registration
- Description of Services – Class 35

Applicant responds as follows.

**Foreign Registration Certificate**

The corresponding Canadian application, Ser. No. 1783665, which serves as a filing basis for the application herein, was registered 27 February 2018, as Reg. No. TMA991462. A photocopy of the Canadian registration certificate is attached.

Applicant notes that the claim of color, services listing, and filing basis are presented in the French language only. Respective English translations prepared by the undersigned are provided below:

*Color claim:*

The red color of the letters RM and the lightning bolt in the 0, and the black color of the letters STATOR are claimed as a feature of the trade-mark.

*Services:*

Manufacturing and sales, namely: Electrical, electronic, and other parts and accessories for motorsport vehicles, namely stators, voltage regulators, voltage rectifiers, CDI electronics boxes, distributors, alternator rotors, starting motors, timing sensors, back plates, charging kits, connectors, ignition coils, ignition cables, light bulbs, starter solenoids, contact keys, lighting coils, pulse sensors, distributor caps, bushes, starter brushes, starter starter pinions and armatures.

*Claim / filing basis:*

Used in Canada since at least as early as about August 2005 in connection with the services.

## **IDENTIFICATION OF SERVICES**

The Examining Attorney has noted a discrepancy in the punctuation of the recitation of services in Class 35, namely that a colon “:” should be replaced by a comma. Applicant has amended the services description accordingly, as shown below:

Retail and online store services featuring parts and electrical accessories for motorized sport or powersport vehicles, namely stators, voltage regulators, voltage rectifiers, CDI electronics boxes, alternators, generators, steering motors, timing lights and timing sensors, back plates, charging kits, starter kits, connectors, ignition coils, harnesses, light bulbs, ignition coils, ignition keys, pulse sensors, lighting coils, distributors, distributor caps, spark

plugs, ignition cables, ignition wires, starter brushes, starter pinions and armatures, starter solenoids and solenoid switches.

## **CONCLUSION**

The undersigned certifies that he translated the portions of the Canadian registration noted above.

Applicant believes that it has responded to all grounds of concern raised by the Examining Attorney, and that the Application is in condition for allowance and publication.
