LETTER OF CONSENT

This Letter of Consent, effective 2 brunn 1th, 2016, is by and between DCore Lifestyle Inc. ("DCore"), a Canada corporation with a principal address of 1175 Place du Frère André, Montreal, Quebec CANADA H3B3X9 and Port Excel International Limited ("Port Excel") a British Virgin Islands limited liability company with a principal address of Ying Piu Mansion, Flat A, 32/F, 1 Breezy Path, Hong Kong

DCore is the owns various pending trademark applications for the word mark MOMENTO, including U.S. Application No. 86329917, U.S. Application No. 86329932, and U.S. Application No. 86329902 and also owns pending trademark applications for the design shown below, including U.S. Application No. 85911335.



Port Excel owns various trademark registrations for the stylized MOMENTO design shown below, including U.S. Registration No. 3589766 (collectively, the "Port Excel Mark").



The U.S. Patent and Trademark Office (PTO) initially refused registration of DCore's U.S. Applications for the MOMENTO marks based on an alleged likelihood of confusion under Section 2(d) of the Trademark Act with the mark in Port Excel's U.S. Registration No. 3589766;

DCore filed Cancellation Proceeding No. 92060085 against Port Excel's U.S. Registration No. 3589766 alleging abandonment under Trademark Act Section 14.

The Parties wish to resolve this matter amicably, without need for further proceedings.

Therefore:

1. Port Excel agrees to amend U.S. Registration No. 3589766 to delete the goods underlined in the excerpt below:

(Int'l Class: 24) Bed blankets, baby blankets, bedding, namely, quilts, bedspreads and mattress covers, bed linen, namely, flat sheets, bed canopies, bath linen, bath towels, crib bumpers, curtains, cloth flags, cloth pennants, duvets, duvet covers, eiderdowns, eiderdown covers and coordinated bed accessories, namely, pillowcases, bed sheets, pillow covers, fabric flags, felt pennants; unfitted fabric furniture covers, wall hangings of textile, upholstery fabrics, household and home textile articles, namely, napkins, napkins of cloth for removal make-up and table napkins of textile, golf towels, hand towels, handkerchiefs, hooded towels, household linen, kitchen towels, receiving blankets, silk

blankets, <u>table linen</u>, <u>textile napkins</u>, <u>textile place mats</u>, <u>textile tablecloths</u>, throws, towels, washcloths, woolen blankets, unfitted fabric bed <u>and table covers</u>, and shower curtains.

- 2. In the United States, Port Excel shall only use the Port Excel Mark, or any MOMENTO-formative mark, in connection with the amended goods referenced in Paragraph 1 above.
- 3. Port Excel shall never use, attempt to register, or register the trademark MOMENTO alone, or with any terms or designs, including without limitation the Port Excel Mark, in connection with any goods or services outside of International Class 24, in any jurisdiction in the world.
- 4. Port Excel consents to the registration of DCore's MOMENTO marks

Each party has extensive knowledge about its own business and about the marketplace for its products and services. There are differences between the DCore goods and Port Excel goods under the respective marks. The intended consumers of the parties' products are sophisticated and use great care in selecting the identified products; therefore, these consumers are able to distinguish between the marks and the identified products. Neither party is aware of any instance of actual confusion arising from the advertising or use of their respective marks on their respective products. The parties expressly agree that in the unlikely event that they learn of any actual confusion as a result of advertising or use of their respective marks, they will work together in good faith to alleviate such confusion.

In view of the foregoing, the parties believe that there is no likelihood of confusion arising from concurrent registration of their respective marks on or in connection with the parties' respective products.
