# SLEEP LOGIC® LIMITED WARRANTY

(See list above for duration of the warranty on the specific SleepLogic mattress or box spring which you purchased.)

#### WHAT IS COVERED?

Your warranty covers manufacturing defects in your SleepLogic® mattress or foundation. This warranty is limited to the consumer who originally purchased the product. The following items are covered under normal wear:

#### Mattress

- · Coils or wires that are loose, broken or protruding through
- · Sagging, only if the mattress has been continuously supported by matching foundation (or equivalent) and used with an appropriate frame and center support, or a minimum of 5 hardwood cross-slats with center support
- Fabric handles sewn to mattress
- Body impressions of 2" or greater on both sides of mattress (or on one side for a single-sided mattress)

#### Foundation

- · Splits in the wood frame
- Bent, loose or defective wood beams and/or center
- · Compression or unstapling of boxspring coils
- · Broken or loose boxspring coils
- Sagging, but only when continuously supported with an appropriate frame and center support, or a minimum of 5 hardwood cross-slats and center support

## WHAT WILL SLEEP LOGIC DO?

If your SleepLogic® mattress or foundation fails due to manufacturing defect, SleepLogic® will, at its option, either repair or replace the defective item.

Replacement or repair of one piece does not automatically result in the replacement or repair of another piece. SleepLogic® reserves the right to substitute comparable materials or models and does not guarantee that the replacement will match the defective piece.

## HOW LONG IS THE WARRANTY COVERAGE PERIOD?

The warranty is for a period of time based upon the code on your law label (see chart above) starting with the original date of purchase. Repair or replacement of the mattress or foundation does not extend this warranty period or begin a new limited warranty period.

During the "free" period of your warranty, SleepLogic® will repair or replace the defective piece at no charge (except for transportation costs to and from our factory in Cleveland, Ohio). After the "free" period has expired, all repairs or replacements will be done on a pro-rated basis, based upon the current retail prices of the model purchased, or comparable model.

### WHAT IS EXCLUDED UNDER THIS WARRANTY?

This warranty does not apply to items such as, but not limited to:

- Normal body impressions of 2" or greater on only one side or 2" or less on both sides of mattress
- Commercial Use
- Comfort or Firmness preference
- Product that is shipped outside of the continental U.S.
- · Product that is stained, burned, in an unsanitary condition, or otherwise abused
- · Product not maintained in accordance with the Care Instructions in this warranty card
- Full XL, Queen, or King sized bedding that is used on a metal frame, bed base or rail system (headboard/footboard) that does NOT have a rigid center support and at least 5 legs or 5 hardwood cross-slats
- · Fabric (cover)
- Bent foundation or mattress border/edge wires
- Corner guards

THE FOREGOING LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE OR MERCHANTABILITY. IN NO EVENT SHALL SLEEP LOGIC\* BE RESPONSIBLE TO PAY FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES.
