### DIRECTIONS FOR USE and FOLIAR APPLICATION RATES

This product contains kelp and is highly saturated. The contents may settle out to some degree over time and should be shaken lightly before adding it to a mixing tank. No additional surfactant is required when using **Grigg Brothers® Ultraplex®**.

**IMPORTANT:** For best results apply as a foliar spray early in the morning or late evening. Allow to dry 3-6 hours before irrigation.

**TURF GRASSES: Cool or Warm Season:** Use 3 ounces of **Ultraplex®** in combination with other **Grigg Brothers®** products. Use 6 ounce rate when **Ultraplex®** is applied without other **Grigg Brothers®** products. Weekly or as needed.

Foliar fertilizer is intended as a supplement to a regular fertilization program and may not, by itself, provide all the nutrients normally required by turf grasses.
