ENSURE CANDIDATE HAS HAD NOTHING IN THEIR MOUTH FOR 10 MINUTES

Escort candidate to designated area for oral drug screening. Review Oral Drug Screen Notice and Chain of Custody form. Company representative and candidate complete top portion.

PRODUCT COMPONENTS



Store OralStat at room temperature Verify expiration date labeled on the product pouch. Note the number of drugs being tested, either 6 or 10. labeled on the product pouch.

Do not use past expiration date.

With a black marker write the last four digits of the candidate's social security number on both the test slide and the device.

Check that the test slide is in the up position with the feet of the tabs resting on the top of the device. If it is not, pull up gently before proceeding with the test.



CAPTURE CANDIDATE INFORMATION: COMPANY REPRESENTATIVE



Begin program by clicking on the Rapid Reader icon.

In the tool bar of the home page select "New Reading".

TEST PREPARATION: COMPANY REPRESENTATIVE

Keeping the device on a flat surface



Remove blue label from back of device.





Gently slide the device from side to side along a flat surface for at least 3 seconds.

Insert the handle of the collection swab into each of the "A" wells, pushing down completely, until it stops. (you will feel a click)

SPECIMEN COLLECTION: CANDIDATE

Instruct candidate to remove cover from the collection swab and insert between cheek and gum for at least 1 minute on each side of the mouth.

> (Set timer for 2 minutes) Continue until the sponges are fully expanded.





TEST PROCEDURE:CANDIDATE

On a flat surface, instruct the donor to gently drop the swab into center well "B" allowing it to settle vertically.

Push the swab down **slowly** and completely until it clicks into place.

Wait 5 seconds.

Gently slide the device from side to side along a flat surface for at least 3 seconds.



PLACE ORALSTAT TEST SLIDE INTO READER TRAY

Line intensities may vary

If one or more "Test Valid" lines do not appear discard test and re-test with a new OralStat.

Place the test slide into the Rapid Reader trav. Ensure that the test slide is facing up.

Slide the tray into the Rapid Reader.

The test slide must be placed into the Rapid Reader within 2 minutes of verifying the presence of both test valid lines.

The Rapid Reader tray must be pushed into the Rapid Reader completely.
