**How the NASDAQ OMX Listing Center Process Works**

**US Markets**

The NASDAQ OMX Listing Center now supports the electronic submission of Listing of Additional Shares (LAS) Notification Forms in addition to Listing Applications. In the coming months, NASDAQ will continue to add functionality to this electronic portal, with the goal of eventually migrating all paper-based forms to this platform. We expect to begin accepting Corporate Governance Interpretation Requests electronically before the end of 2010.

Once you create a user account, you can select the type of application or notification form you wish to complete. At any time, you may save your work and complete it at a later time. Within a few days of your submission, you will receive an email detailing your Listing Analyst's contact information.

Please note that prior to starting you will need the following Company information: [Central Index Key \(CIK\) code](#), its current trading symbol and [CUSIP](#), and its reserved trading symbol, if different from the Company's current symbol. This information will allow NASDAQ to search its extensive corporate database, [ExACT™](#), and pre-populate some of the general company information, such as your Company's name and address, required in order to complete a Listing Application or Notification Form.

Our online Listing Center will also allow you to upload any supporting documentation, including your completed Listing Agreement and Corporate Governance Certification Form. **Nordic Markets**

All Issuers that wish to list warrants, certificates or exchange traded funds (ETFs) on NASDAQ OMX Nordic may do so electronically using our online Listing Center. Our system will also allow users upload supporting documentation, including your completed Listing Form and Final Terms. At any time, you may save your work and complete it at a later time. Shortly after your submission the local surveillance team will send you the relevant contact details.

Please note that before an application can be approved, an Issuer must be approved as an Issuer for the listing of warrants, certificates or ETFs by the exchange and must also sign an undertaking to comply with the Rulebook.
