GENERAL INFORMATION

FoliMar ZinCa Bloom 5-0-0 is formulated for foliar applications to correct or prevent calcium or zinc deficiencies in plants. Be aware of applying to sensitive crops such as leafy vegetables in areas of extreme temperatures as it may cause surface injury to the plant.



DIRECTIONS FOR USE

FoliMar ZinCa Bloom 5-0-0 may be applied as a foliar spray, aerial or by ground application; make sure to spray thoroughly and even coverage for maximum uptake and nutrient safety. Include high quality wetting agent at recommended rates. Optimum rate of application are very based on different factors.

FOLIAR APPLICATION:

For row crops, vegetable crops including fruit vegetables, tree, and shrub crops, apply 1-4 pints per acre.

GROUND APPLICATION RATES

Apply FoliMar ZinCa Bloom 5-0-0 with sufficient water to provide desired coverage. When very low volumes of water are used, a slight burning of the foliage may occur. Ground applications should not exceed 1 quart per gallon of water.

AERIAL APPLICATION RATES

Usually a minimum of 5 gallons of water per acre is sufficient to apply the necessary amount of FoliMar water to used, a slight burning of the foliage may occur. Aerial applications should not exceed 1 quart per gallon of water.

NOTE: Do not mix FoliMar ZinCa Bloom 5-0-0 with sulfate or phosphate-based acidifying agents, buffering agents, or fertilizers. Do not combine with copper plant protection products if spray solution has a pH of 7.0 or less. Avoid tank mixing with liquid lime sulfur. For specific crop recommendations or questions consult your Mar Vista Resourcess sales representative.

Use in accordance with recommendations of qualified individual or institution such as, but not limited to, a certain crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan. When tank mixing other products, "jar test" proportionally mixed components to confirm compatibility.

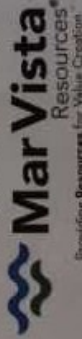
