RESPONSE TO OFFICE ACTION DATED JUNE 2, 2015

The Post Registration Office Action dated June 2, 2015, for the above-referenced registration has been received and its contents carefully noted. The Office Action refusing to accept Registrant's Section 8 Affidavit filed on October 28, 2014, raises two issues: (1) Ownership (Chain of Title) and (2) Deficiency Fee Notice.

1. Ownership – Chain of Title

The Post Registration Examiner, Ms. Singh, stated in the Office Action that Registrant G4S Technology Limited, a Company of the United Kingdom (the party signing the Sections 8 & 9 Combined Declaration of Use/Application for Renewal of Registration of a Mark) did not establish clear ownership of the registration in the PTO records. Registrant believed that its original chain of title filings made on March 28, 2015 properly demonstrated that the Registration was owned by Registrant.

It came to Registrant's attention, however, that on the original name change document, Registrant misidentified the Conveying Party as Group 4 Technology Limited (*Limited Liability Company of England*) and the Receiving Party as G4S Technology Limited (*Limited Liability Company of England*). Instead, however, both the Conveying Party and Receiving Party should have been identified as a *United Kingdom Company*. After a conversation with Ms. Singh, Registrant duly filed a corrective recordal to show clear chain of title in *G4S Technology Limited, a United Kingdom Company*. This step is summarized as follows:

- Registrant filed a corrective assignment to correct the change of name previously recorded on Reel 5487, Frame 0402, confirming the change of name from Group 4 Technology Limited (United Kingdom Company) to G4S Technology Limited (United Kingdom Company)(Reel 5574, Frame 0488).

Accordingly, there is now a clear chain of title to the party who executed the Combined Affidavit, G4S Technology Limited (a United Kingdom Company). Registrant attaches a print out

of the current Trademark Assignment Abstract of Title for the above-referenced trademark registration for ease of reference.

2. Deficiency Fee

Registrant, through the online TEAS form, has paid the \$100 deficiency fee.

In Ms. Singh's first Office Action dated November 13, 2014, she required a substitute specimen. Registrant filed a substitute specimen in the post-registration office action response dated May 13, 2015. After a conversation with Ms. Singh on July 8, 2015, Registrant understands that the substitute specimens have been accepted and that issue is no longer outstanding.

In conclusion, Registrant believes it has addressed all issues identified in the Post Registration Office Action and respectfully requests that Registrant's Section 8 filing made on October 18, 2014 be accepted.
