This STATEMENT is submitted in response to a Post-Registration Office Action mailed April 15, 2016, and to a telephone interview with the Examiner on April 15, 2016.

On April 12, 2016, the Registrant, CELLULAR TECHNOLOGY LIMITED, submitted a Section 7(h) Request for Correction to the above Registration to amend the identification of the corporate status of the Registrant to be an "OHIO LIMITED LIABILITY CORPORATION."

In the Office Action, the Section 7 Request was not accepted because there was no verified affidavit or declaration stating that the error in the Registrant's status explaining in good faith how the error occurred was not submitted.

Registrant's representative believes the incorrect corporate identification of the status of the Registrant to be: "Cellular Technology Limited, a limited liability company legally organized under the laws of Ohio."

Registrant's representative filed the Section 7 Request for Correction to amend the identification of Registrant's corporate status to be: "Cellular Technology Limited (Ohio Limited Liability Corporation), a limited liability company legally organized under the laws of Ohio."

During the telephone interview with the Examiner, Registrant's representative was informed that the change in corporate status was acceptable, but a verified statement of good faith was required. That Good Faith Statement is below.


Registrant's representative declares the error in corporate status to have been made in good faith and with no intent to deceive. The undersigned, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C.

§1001, and that such willful false statement may jeopardize the validity of this document, declares that s/he is properly authorized to execute this declaration on behalf of the owner, and all statements made of his/her own knowledge are true and that all statements made on information and belief are believed to be true.
