First is the placement, translation and explanation of hadith narratives which are acceptable and second is critical evaluation of narratives that stand rejected. This work is being done in two languages simultaneously (English and Urdu) and will soon be appearing in monthly journals Ishraq and Renaissance. It will also be published in the form of a book when all the hadiths have been reviewed.
Audio visual project - Al-Mawrid is a global organization and has found digital media to be the most efficient and cost-effective means of communicating with audience across the globe. This requires them to depend on the
