



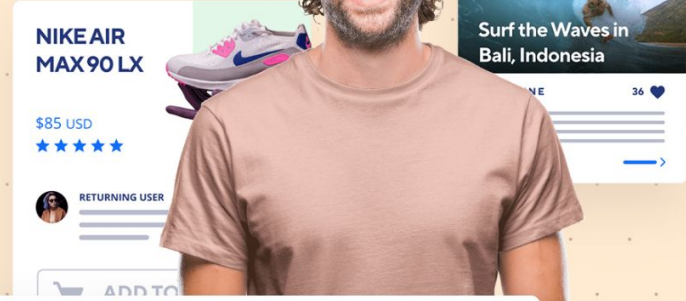

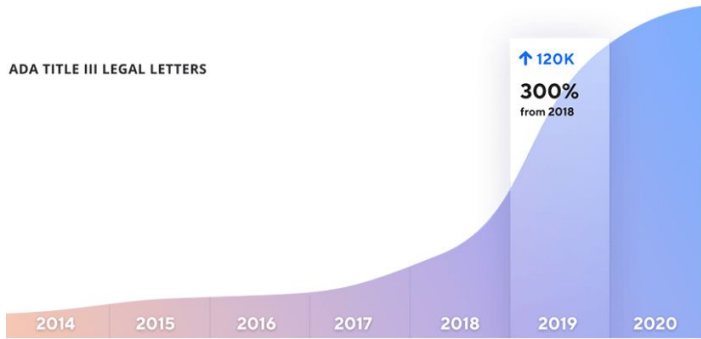
Which businesses must have compliant websites?

Frequently asked questions

How do I become compliant?

In order for your website to be compliant, you will need to follow and implement WCAG (Web Content Accessibility Guidelines) 2.1 level AA requirements.

Why isn't my website compliant?

Web accessibility is very complex. Therefore, most platforms cannot incorporate the requirements by default. If your website didn't go through a remediation process, it most likely isn't compliant.

Can I settle my lawsuit with the aCe report?

aCe has no legal authority, but it does provide your compliance status as of testing date, which can help you and your team decide on a course of action.



Does aCe collect data from my website?

aCe does not collect data from your website and it is compliant with data privacy regulations such as GDPR and CCPA.

What do I do with the results?

aCe breaks down all WCAG requirements and highlights how your site adheres to them, the report can be used by developers or by accessibility solutions to fully remediate your site.

How accurate is aCe?

aCe uses accessible's AI engines and API to evaluate your website to deliver results as accurate as manual accessibility testing.

Why is aCe more reliable than other testing tools?

While most tools are only able to flag some errors (inaccurately) based on presets, by utilizing accessible's AI, aCe is able to determine compliance status similarly to how a human would have.

Can aCe make my website compliant?

aCe is an accessibility auditing tool, not a remediation one. aCe is specifically designed to give you an accurate audit of your compliance status.

Can aCe tell me if I comply with legislation such as ADA and 508?

aCe detects compliance according to the WCAG which is widely adopted by legislation around the world, ADA, AODA, EEA, IS5568 and others.
