### TERMS AND CONDITIONS

Goods must be counted upon receipt. All claims for defective merchandise must be made in writing by certified mail within 10 days of receipt of goods. Failure to give such notice shall constitute unqualified acceptance and waiver of all claims by the buyer. Written return authorization is required by seller for returns. Any errors in items or price must be reported within 5 days.

#### INSPECTION OF GOODS

It is the buyer's responsibility to inspect all goods received before selling to meet specific requirements, performance standards, or applications especially for color-

It is the buyer's responsibility to inspect all goods received before selling to meet special requirements, performance standards, or applications especially for color-fastness shrinkage,stretch, and general appearance.

Without prejudice to the provisions towards the forwarder, claims regarding any visible defect or non-conformity of the delivered product or any discrepancy with the ordered product or the delivery note have to be submitted in writing within eight days of the delivery date. The customer shall provide efficient proof of the damages or discrepancies noticed.

It is the responsibility of the Buyer to inspect upon receipt that all samples delivered matches its order.

### CASUALTIES

Goods delivered through common carriers or sent via parcel post are at the risk of buyer. In no event shall the seller be liable for loss of profits, late deliveries, or any damages as a result of any shipping carrier.

#### WARRANTIES

Seller makes no warranty, either express or implied, of merchantability or of fitness of goods for any specific purpose unless clearly specified.

#### PAYMENT

Payment are due within the time period specified on the invoice. Upon failure of the buyer to make timely payments, buyer agrees to pay any and all cost of collection and litigation (Including but not limited to attorney fees and interest at the rate of 1.5% per month). Orders are accepted subject to credit approval and stock availability. No cancellation is allowed 10 days prior to the ship or cancel date. (Cancel date means last day on which the merchandise can be shipped from the warehouse)
