## APPLICATION INSTRUCTIONS

The recommended application rate is 6 oz/acre. Short duration crops need only 1 application while other crops may need 2 or more applications. Dilute RIJEN with water in the ratio of 1:400 to 1:2000 before applying to soil using standard spraying equipment or existing irrigation system. For best results, make sure soil pH is between 5.5 and 7.5 prior to application and reduce chemical fertilizers by at least 50%. For poor soils, apply more often until the soil has been revitalized.

### SHORT DURATION CROPS

Apply at the rate of 6 oz/acre right after seeding or transplantation.

### LONG DURATION CROPS

Apply at the rate of 6 oz/acre for each treatment. For best results, apply first treatment right after planting or at leaf emergence, and second treatment at the start of vegetative growth, typically 4 weeks after leaf emergence. A third (optional) treatment can be applied at the start of flowering. Additional treatments may be applied throughout growing season depending on your preference.

### HOME GARDENS

Dilute 1 teaspoon into 2 gallons of water (1:2000 ratio) and use the solution to water the plants once a week instead of plain water.

For specific instructions for individual crop types and soil conditions, consult with your distributor after obtaining soil sample analysis results.
