RESPONSE TO FINAL OFFICE ACTION

Applicant has received and reviewed the final Office Action dated September 10, 2021,

from Examining Attorney Tejbir Singh, Law Office 106, regarding the above-referenced

application for FACEBOOK, Serial No. 90/157,769 ("Applicant's Mark"), which requests

amendments to the goods and services described therein. Applicant responds to the issues raised
