As owner of trademark Registration No. 4580953 for the mark CAPSOL-TSR, this will confirm the position of Mor-NuTech, Inc. that there is no conflict or likelihood of confusion between our mark CAPSOL-TSR, as used for the services specified in said registration, and the mark TSR as used in connection with the goods set forth in application Serial No. 86/386081. Pursuant to the Trademark Coexistence Agreement between the parties, Mor-NuTech, Inc., hereby consents to the registration of Serial No. 86/386081.

It is my belief that there is no conflict or likelihood of confusion between our CAPSOL-TSR mark and the mark TSR which is the subject of Serial No. 86/386081. This belief is based on the following:

The respective marks are substantially dissimilar in their entirety as to appearance, sound, and commercial impression. We are confident that consumers of the parties' respective products, who are highly sophisticated, will be able to distinguish these marks in the marketplace, and that these differences essentially obviate any real concern about a likelihood of confusion between the marks.

The marks have been in use by their respective parties for at least three years, and Mor-NuTech, Inc. is not aware of any actual confusion between the marks.

Mor-NuTech, Inc. and Zhejiang Tianshun Biotechnology Co. Ltd. have agreed to undertake mutually agreed upon best efforts to avoid any potential or actual confusion between their respective marks.

Accordingly, as owner of Reg. No. 4580953 for the mark CAPSOL-TSR, Mor-NuTech, Inc. believes that these marks can coexist in the marketplace without confusion, and that likelihood of confusion does not exist. Mor-NuTech therefore consents to the registration by Zhejiang Tianshun Biotechnology Co. Ltd. of the trademark TSR for the goods specified in Zhejiang Tianshun Biotechnology Co. Ltd.'s application Ser. No. 86/386081.

Mor-NuTech, Inc. will execute and file with the United States Patent and Trademark Office any and all documents which may be necessary or proper to effectuate the terms of this Consent. If this Consent is accepted by the Examining Attorney assigned to Zhejiang Tianshun Biotechnology Co. Ltd.'s application Serial No. 86/386081, Mor-NuTech, Inc. will take any further actions and execute any further agreements needed to carry out the spirit and intent of this Consent.
