2(d) Refusal Response:

The Office Action dated May 12, 2016 has been carefully considered. In the Office Action, the Examining Attorney refused registration of U.S. Trademark Application Serial No. 86/885,766 for ILP (hereinafter “Applicant’s Mark”) in connection with “Services in the nature of software as a service featuring computer software platforms for financial trading transactions” in Class 42 based on the likelihood of confusion with the following registration owned by ILP Network, LLC:



(U.S. Trademark Registration No. 4630677) in connection with “Advertising and promotional services on behalf of others; promotional services, namely, promoting the goods and services of others by distributing advertising material, coupons or discount offers via online entertainment websites, on the internet and other communications networks; Development of advertising campaigns for webpages which allow advertisers, marketers and content providers to reach, engage, and interact with online users for the purposes of promotion or advertising” in Class 35;

“Audio, video and multimedia broadcasting via the Internet and other communications networks; webcasting services; transmission of messages, data and content via the Internet and other communications networks; providing forums and chat rooms for the transmission of messages, comments and multimedia content among users in the field of general interest via the Internet and other communications networks; transmission of electronic media, multimedia content, videos, movies, pictures, images, text, photos, user-generated content, audio content, and information via the Internet and other communications networks; providing community forums for users to post, search, watch, share, critique, rate, and comment on, videos and other multimedia content via the Internet and other communications networks” in Class 38;

“Online digital video, audio and multimedia entertainment publishing services; Entertainment services, namely, conducting contests; entertainment in the nature of providing an informational and entertainment website in the fields of celebrity gossip, entertainment, sports and fitness; providing a website featuring entertainment information; providing a website for entertainment purposes featuring photos, videos, movies, images, texts, and pictures about social happenings; providing an internet website portal in the field of entertainment, cultural and sporting events” in Class 41; and

“Providing a website that gives computer, laptop, and mobile electronic device users the ability to upload and share user-generated videos, pictures, images, photos, essays and articles on a wide variety of topics and subjects” in Class 42 (hereinafter, “the Cited Registration”).

In order to determine whether there is a likelihood of confusion between an applied-for mark and a cited mark, an Examining Attorney must analyze each case in several steps. An Examining Attorney must compare the services of the parties’ marks to determine if they are related or if the activities surrounding their marketing are such that confusion as to origin is likely. *In re International Telephone and Telegraph Corp.*, 197 USPQ 910 (TTAB 1978). Additionally, the Examining Attorney must look at the marks themselves for similarities in appearance, sound, connotation and commercial impression. *In re E.I. DuPont de Nemours & Co.*, 476 F.2d 1357, 177 USPQ 563 (CCPA 1973).

When applying the aforementioned standard, Applicant respectfully disagrees with the Examining Attorney’s position. For the reasons set forth below, Applicant’s Mark, when used with the designated services is not likely to cause confusion with the Cited Registration, and reconsideration of the refusal is therefore respectfully requested.

#### A. There are Differences between Applicant’s Mark and the Cited Registration

When analyzing the marks for similarities, an Examining Attorney must view trademarks as a whole, and as a result, the commercial impression of a trademark is derived from the combination of its component parts and not from each individual component. *Estate of P.D. Beckwith, Inc. v. Commissioner of Patents*, 252 U.S. 538, 345-46, 40 S. Ct. 414, 64 L. Ed. 705 (1920); *Franklin Mint Corp. v. Master Mfg. Co.*, 667 F.2d 1 005; 212 USPQ 233 (CCPA 1981) (“It is axiomatic that a mark should not be dissected and considered piecemeal; rather, it must be considered as a whole in determining likelihood of confusion”). Normally, the presumption is that the word portion of the mark is dominant to the corresponding element; however, that presumption is a guideline, not a rule. *In re Sloppy Joe’s Int’l Inc.*, 43 U.S.P.Q2d 1350, 1354 (TTAB 1997) (emphasis added).

Applicant contends that in this case, the design element of the Cited Registration is dominant in light of the sheer size and visual impact of the design element, which wholly encompasses the word element. *See In re: White Rock Distilleries, Inc.*, Serial No. 77093221 (TTAB 2009) (precedential) (holding that the prominent design feature of the registered mark served to visually distinguish it from applicant’s mark and reversing the likelihood of confusion refusal); *Gaston’s White River Resort v. Rush*, 701 F. Supp. 1431, 1438 (WD Ark., 1988) (finding that the visual impact of a composite mark on the consuming public should be considered and a logo or pictorial element can be deemed dominant when it is “so impressive that the... words cannot offset the overall design” (quoting *Finn v. Copper’s, Inc.*, 292 F.2d 555 (CCPA 1961))).

In this instance, the Cited Registration is comprised of a large, red, bleeding heart with the term “ILP” in small font on a small white banner running across the heart. Additionally, the heart has three streaks of blood running down the right side of the heart. Similar to the cases mentioned above, the size of the design element in comparison to the words is so prominent that the design element should be considered the dominant portion of the mark. Additionally, the style and color

of the design, particularly the red blood streaks, draws consumers' attention to the design first and then to the word element.

Moreover, even though Applicant's Mark is a word mark we cannot assume that Applicant's Mark would also encompass and protect rights in the word "ILP" and a design similar to the Cited Registration. *See Fossil, Inc. v. The Fossil Group*, 49 USPQ2d 1451, 1454 (TTAB 1998) ("[O]pposer's typed drawing registrations of FOSSIL afford opposer a scope of protection which encompasses all reasonable manners in which the word FOSSIL could be depicted including, simply by way of example, all lower case block letters, all upper case block letters, a mixture of lower case and upper case block letters and various script forms. However, opposer's registrations of the word FOSSIL in typed drawing form do not afford opposer rights in the word FOSSIL combined with other wording or with designs") (emphasis added). Therefore, Applicant's Mark would never be afforded protection of a logo similar to the Cited Registration. Given that the design element is the dominant portion of the Cited Registration, there are sufficient differences in appearance, as to not cause a likelihood of confusion between the Cited Registration and Applicant's Mark.

**B. There are Differences in the Commercial Impression of the Cited Registration and Applicant's Mark**

The "commercial impression" of a trademark is the meaning or idea it conveys or the mental reaction it evokes. *Spice Islands, Inc. v. Frank Tea & Spice Co.*, 505 F.2d 1293, 1296 (C.C.P.A. 1974). Here, Applicant's Mark and the Cited Registration have different impressions. Applicant's Mark is a known acronym for INTERLEDGER PROTOCOL, a term that is uniquely associated with Applicant and its Services (see specimen submitted with the application for Applicant's Mark). "INTERLEDGER PROTOCOL" when used in connection with a worldwide network, allows customers to transact across different applications using different currencies. In light of the meaning of Applicant's ILP Mark, and its use in connection with the Proposed Services, ILP could convey: (i) the set of conventions that govern when using Applicant's unitary network to transact across different currencies or applications on the web; (ii) a network that fills in the gap between individual financial systems, currencies, and applications to create a new record of financial transactions when customers in different countries agree to transact using Applicant's network; or (iii) services that allow different financial systems to work together using certain conventions for formatting data.

In contrast, the dominant portion of the Cited Registration is an image of a bleeding heart. A bleeding heart can symbolize: (i) a person who shows profuse sympathy for an object of alleged persecution; (ii) a politically liberal individual who is emotional about certain political issues; (iii) a broken relationship; (iv) betrayal or rejection; or (v) a physical injury or hurt. *See Annex A* for evidence of bleeding heart symbolism. In light of the services associated with the Cited Registration, particularly audio, video and online digital broadcasting and publishing services in connection with entertainment, forums, and user-generated content, the Cited Registration could (and does) convey outlets for users to view, discuss, share, and upload content related to political liberalism, social ills, rejection or physical injury or violence. Indeed, the most prevalent use of the Cited Registration is in connection with third party generated and uploaded videos, many of which depict violence between people. *See Annex B* for said evidence. The use of the term IPL in the case of the Cited Registration could have multiple meanings, as ILP is an acronym for many

different words and phrases. See **Annex C** for a list of ILP meanings. While there may be multiple connotations for the Cited Registration, neither the image of the bleeding heart nor ILP (outside of the meaning ascribed by Applicant) convey Applicant's Services, namely software for financial trading transactions. Accordingly, the different commercial impressions between Applicant's Mark and the Cited Registration also do not weigh in favor of a likelihood of confusion between the two.

C. The Services Offered Under each Mark are Sufficiently Unrelated so as to Alleviate any Likelihood of Confusion

In multiple cases, the TTAB has held that there cannot be a rule that certain goods or services are per se related. See, e.g., *Information Resources Inc. v. X\*Press Information Services*, 6 U.S.P.Q. 2d 1034, 1038 (TTAB 1998); *Hi Country Foods Corp. v. Hi Country Beef Jerky*, 4 U.S.P.Q. 2d 1169, 1171 (TTAB 1987). Instead, when determining whether services are related for purposes of a likelihood of confusion analysis, the specific attributes of the services should be compared rather than broad categories of services. See *McGregor Doniger, Inc. v. Drizzle, Inc.*, 599 F.2d 1126, 1132, 202 U.S.P.Q. 81 (2d Cir. 1979). If the services associated with two marks "are not related or marketed in such a way that they would be encountered by the same person in situations that would create the incorrect assumption that they originate from the same source, then even if the marks are identical, confusion is not likely." TMEP §1207.01(a)(i).

In this instance, Applicant's Services are narrowly tailored to software as a service for financial trading transactions. In contrast, Registrant's Services focus on providing a website, forum, publishing and broadcasting services, namely in the entertainment industry. The Examining Attorney takes issue with the Registrant's description of its Class 42 services, namely because of the breadth of services. As the Examining Attorney puts it "[a]ccordingly, registrant's providing a website that gives computer, laptop, and mobile electronic device users the ability to upload and share user-generated videos, pictures, images, photos, essays and articles on a wide variety of topics and subjects is written broad enough to encompass use of applicant's software as a service featuring computer software platforms for financial trading transactions." Applicant respectfully disagrees. This is an over simplification of the services of both marks and also not an accurate representation of the marks or how they are being used.

Foremost, the Examining Attorney has not provided any evidence of any similarity between the services offered under Applicant's Marks (software and software platform for financial trading transactions) and those services offered under the Cited Registration (website for uploading user generated content). There is no evidence of record that all of these services originate from the same source; therefore, the Examining Attorney has not met the burden of showing that the respective goods would cause a likelihood of confusion. See TMEP § 710.01 (stating that the Examining Attorney must always support his/her action with relevant evidence and place such evidence in the record with copies sent to the Applicant).

When comparing the specific services provided by the parties rather than comparing broad categories of services, it is apparent that the Applicant's Services and the Registrant's Services are sufficiently unrelated. On the broadest level, Applicant and Registrant's services are both internet based, but that is where all similarity ends. Providing a website for uploading user-generated

videos, pictures, images, photos, essays, and articles is not the same as providing a software as a services platform for financial trading transactions. The Cited Registrant's Class 41 description conveys services tantamount to YouTube or a social media site, and in fact, the use of the Cited Registration in connection with Registrant's services is very similar to YouTube. **See Annex B** showing the same. A review of the Registrant's website [www.ilpvideo.com](http://www.ilpvideo.com) confirms that the services offered by the Registrant are that of a "Video Tube," specifically featuring hip hop videos and content involving violent and illicit conduct. *Id.* Consumers are unlikely to associate Registrant's YouTube or social media type services with financial trading transactions for several reasons.

First, financial trading transactions are generally conducted by a financial investment or banking institution, and such institutions are not generally associated with or would emanate from the same source as Registrant's services. Second, because financial trading transactions are generally conducted by certain institutions the type of consumers for Applicant's and Registrant's service are different – the former generally being those working in the financial or banking industry. Third, such types of financial transactions are generally confidential and not publically disclosed (beyond required government disclosures) and would not be the source of videos, pictures, images, photos, essays or articles on Registrant's website. Lastly, the Examining Attorney's argument that financial trading transactions could be encompassed into the "wide variety of topics and subjects" is tenuous at best. Not only does the Examining Attorney not provide evidence to support the same, but a review of Registrant's other services clearly indicates that the majority of Registrant's services are related to the entertainment field. As such, consumers would not expect, associate, or believe that financial trading transactions emanate from the same source as entertainment related content.

As a result, consumer confusion is unlikely given that the Applicant and the Registrant "sell distinctly different [services], and contact, for the most part, different people in their marketing efforts." *Heartsprings, Inc.v. Heartspring, Inc.*, 143 F.3d 550, 557 (10th Cir. 1998) (finding no likelihood of confusion between HEARTSPRINGS for educational materials and HEARTSPRING for a residential school for disabled children).

#### D. Conclusion

In light of the foregoing, Applicant's Mark is sufficiently different in appearance, commercial impression, and services offered from the Cited Registration. Such differences weigh against a finding of likelihood of consumer confusion. Accordingly, Applicant respectfully requests that the Examining Attorney withdraw the 2(d) refusal and allow Applicant's Mark to publish.

### Sizing The Artwork

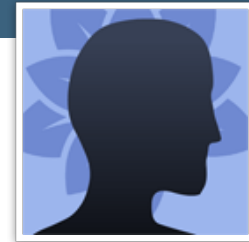

## The Heart with Dagger Tattoo - What Does It Mean?

**HEART WITH DAGGER TATTOO** - The dagger through the heart is a classic piece of tattoo design that has withstood both the test of time and the whim of fashion. Like all enduring symbols, it is as relevant today as when it was first done, managing to successfully capture both our attention and our emotions. In many Christian-themed tattoos, it is a popular variation of the Catholic Sacred Heart of Mary, representing the grieving Mother of Christ, often called the Lady of Sorrows ("A sword shall pierce through thine own soul also," said Simeon to her in the

But the real power of the image of a dagger through the heart is the combination of two symbols which are well known in their own right. The heart has long represented the seat of the emotions and the very core of a person, as far back in time as early Egypt where it figured prominently in the fate of the soul in the afterlife. Of course today and probably worldwide, we particularly associate it with love, especially romantic love. Similarly, the dagger is not just any weapon. It long ago became the stealthy weapon of choice for assassins since it was easily concealed and quiet. As such, it inflicted much more than just a stab wound, carrying with it an additional sense of betrayal and hurt, since the attacker had to be close to be effective. So, the heart-with-dagger tattoo is essentially the heart in great pain, perhaps mortally wounded, sometimes a love betrayed, and sometimes even a sacrifice made. Whether the bearer of this striking tattoo is choosing to convey a religious conviction, an injury received, or giving us advance notice of what we can expect, there is no mistaking the emotional impact that is the center of this tattoo symbol.

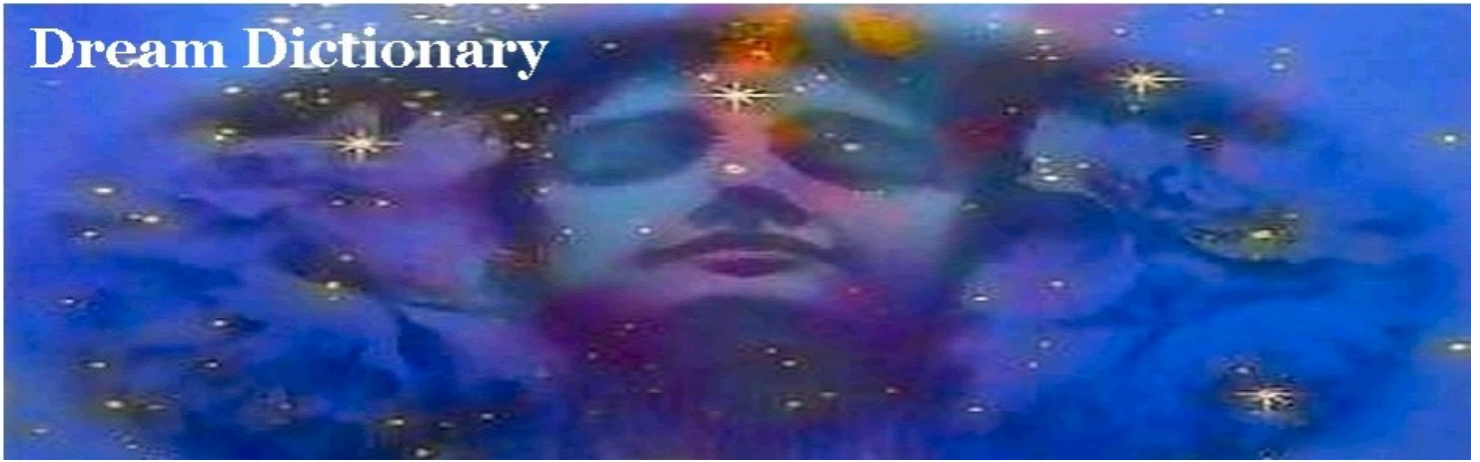

**Blood**

Very often it links with a feeling of being hurt or injured and of losing energy or the strength that enlivens you. But blood can represent pain, but also passions, deep feelings. It can refer to things that are deeply felt. We have passionate involvement with things. There are certain things that enter into us and cut us deeply. In some relationships we are opened up and we bleed even if the relationship is largely joyful, there still may be deeply felt and painful feelings in it.

Blood can also mean fertility as when it is connected with menstruation. It can be a painful cleansing and difficult period of releasing the old. The old dies away and leaves space for the new to grow.

In a more general sense blood can indicate one's energy and sense of existence. In common language we link it with our family through feelings of connection or bonding, inherited tendencies – what we now call genes. It therefore includes inherited strengths and weaknesses of character. We say of such things – its in my blood.

Blood is often used as a symbol of universal life or power in ones life, therefore connection with humanity. Through this it depicts the universal pain or struggle met in human life, along with the possibility of injury and death. In ancient times blood was used as the first ritual sacrament. Later this was symbolised by red wine or red ochre. It was noticed that at times of great change, such as birth or death, blood often preceded the change. Blood was seen as the carrier of the spirit of life and character that lived in a person or animal. If we think of what genes now are known to carry, the untold generations of human life, with all its pain, tragedy and wonder, then blood was seen as carrying this collective human experience.

Blood is sometimes felt as a link with the unconscious forces and sub-personalities within. It is a doorway to the subtle world of the unconscious. This connection is perhaps obvious in that for thousands of years, the blood was seen as the substance that carried in it the mystery of inheritance of physical and psychological features. What we now call genes was represented by the blood, and this is still true in some dreams. The blood in a dream can be the doorway through which you touch your racial and family past. The blood brings to life within you the past lives of those who gave you your body. In quite a real sense they live within you as a great group of people, or influences that need to be integrated for you to become a true individual.

When we see blood on the earth or on someone's clothes, it suggests great injury or death. Blood on the earth therefore marked the spot of either a great battle, a death or a deep wounding. As such it was a marker, a memorial or sign of the act. So this aspect of blood in our dreams must be remembered.

In cultures such as the Macedonian, where symbols were often thought of in terms of good or bad luck, *light blood* represented good news, *dark blood* bad news.

For women there is obviously a strong link between bleeding and menstruation. Therefore in women's dreams involving blood, the blood may depict whatever feelings, pleasure, difficulties are associated with menstruation and the power of female fertility for the dreamer. But you need to look to the theme and drama of the dream to see if this is a correct connection.

**Bleeding:** Most often relates to emotional or psychological hurt, but can also depict physical injury, or presentiment of it. Emotional hurt could mean hurtful remarks, for instance being told we are not loved – these can sap our motive to live and may be depicted as blood. The bleeding might show a psychological injury, often from past trauma, which is causing you to lose energy or motivation.

Sometimes, as mentioned above, the blood can be a sacrament. As such it is not shown as emerging from an injury or wound but as nourishment, wine or bloody meat.

**Blood flowing from a crack:** Possibly menstruation or loss of virginity.

**Blood on the ground:** Someone hurt or dead.

**Bloody clothes:** Personal emotional hurt or injury, perhaps even death of someone.

**Blood Sample:** This can represent many things depending upon the rest of the dream. It could suggest an illness, a way of tracing your identity with DNA, or it could be a drug test.

**Blood sucked from you or sucking from another:** Feeling that you are losing your very life force to someone, or taking energy and life from someone else. Sometimes sex is felt as this. The umbilical connection in the womb is sometimes felt as the life giving connection that if cut off prematurely, is such a loss that expenditure of energy in sex may be felt as vampirism.

**In sexual dreams:** May refer to loss of virginity, menstruation or fertility; or hurt to sexual drive.

**Old or dark blood:** Can sometimes be understood as 'bad blood' existing in the dreamer – bad feelings or old grudges.
