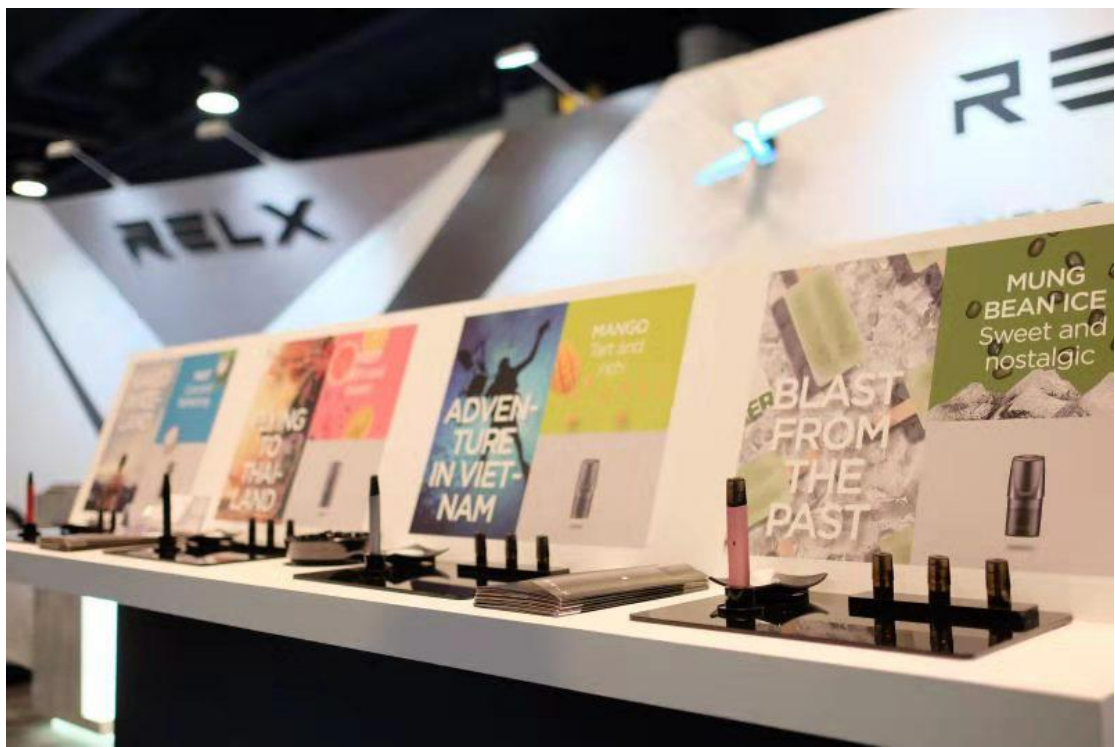

Exhibitor is also required to have organizer Chinese Overseas Marketing Service Corporation insured, including their officer, employees and agents.




