See TSDR records at <u>Exhibit A</u>. CODE is therefore weak and entitled to a narrow scope of protection for consulting and advisory services and CODE marks can coexist based on differences in the precise nature of these services and the target consumers.

With this response, Applicant narrows its services as follows:

Consultancy and advisory services in the field of business strategy, <u>namely</u>, <u>strategies for optimizing clinical trial</u> <u>operations</u>; business assessment services, namely, providing analysis of <u>clinical trial</u> business practices in order to improve people, process, and technology strategies; business consultation regarding launching of new <u>drug</u>, <u>pharmaceutical</u>, <u>and medical device</u> products, <u>excluding</u> <u>advertising</u>, <u>marketing</u>, <u>and promotion of such products</u>

These amendments make clear that Applicant's consulting services do not overlap with the cited registrant's promotion and marketing consulting services because Applicant's services now specifically exclude advertising, marketing, and promotion. It is likewise clear that Applicant's services do not overlap with the cited applicant's advertising services, because again, advertising is specifically excluded from Applicant's services, nor do they overlap with the cited applicant's consulting services relate to clinical trials and drug, pharmaceutical, and medical device products while the cited applicant's business consulting services relate to music.

Given the differences in the parties' services and the consumers to whom they are directed, confusion is unlikely and Applicant asks that the Examining Attorney withdraw the refusals and approve this application for publication. EXHIBIT A
