


In the Office Action issued December 20, 2018, the Examining Attorney notified Applicant of a potential Section 2(d) refusal based on two prior-pending applications (U.S. Application Serial Nos. 86774030 and 87256861). In response, Applicant directs the Examining Attorney's attention to the attached Notices of Abandonment issued on March 6, 2019, and January 15, 2019 as to U.S. Application Serial Nos. 86774030 and 87256861, respectively. See Exhibit A. As these prior-pending applications have now been abandoned, Applicant respectfully requests that its Application Serial No. 88111400 proceed.

Furthermore, the Examining Attorney requested that Applicant clarify the descriptions of certain services in Classes 35 and 36. The amendments to the identification of services submitted herewith respond to the majority of the Examining Attorney's requested Amendments.

However, the Examining Attorney requested clarification of "Providing electronic mobile payment services for others" in Class 36. Applicant respectfully disagrees that further clarification is necessary since the Trademark Office has accepted "Providing electronic mobile payment services for others" in

the description of services in several registrations, including:  (Registration No. 5223646) and



(Registration No. 5492494) (both for "providing electronic mobile payment services for others") after being examined for publication and registration. See Exhibit B. Therefore, since "providing electronic mobile payment services for others" has been accepted in the registrations above without further clarifying how these services are provided, no further clarification of these services is necessary.

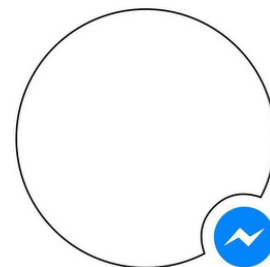
