### I. <u>Introduction</u>

Applicant has applied to register the mark ("Applicant's Mark") for the following goods: "Electric generators; portable electric power generators; component parts for electric generators and portable electric power generators and accessories in the nature of fitted covers for electric generators and portable electric power generators; high pressure washers; pressure washing machines; component parts for high pressure washers and pressure washing machines and accessories in the nature of spray wands, nozzles, hoses, power-operated spray guns and fittings for high pressure washers and pressure washing machines; snow throwers; snow blowers; component parts for snow throwers and snow blowers and accessories in the nature of fitted covers, paddles, blades, and chutes for snow throwers and snow blowers" in International Class 7. ("Applicant's Goods").

The Examining Attorney originally refused registration under § 2(e)(2) on the basis that Applicant's Mark is primarily geographically descriptive, and Applicant submitted a claim of acquired distinctiveness under § 2(f) based on Applicant's ownership of prior US Reg. Nos. 4376750, 4459489, 5372629 and others (the "**Prior Registrations**").

In the present office action issued on November 22, 2019, the Examining Attorney accepted Applicant's § 2(f) claim in part as follows:

- § 2(f) Accepted Goods: snow throwers; snow blowers; component parts for snow throwers and snow blowers and accessories in the nature of fitted covers, paddles, blades, and chutes for snow throwers and snow blowers
- § 2(f) Refused Goods: electric generators; portable electric power generators; component parts for electric generators and portable electric power generators and accessories in the nature of fitted covers for electric generators and portable electric power generators; high pressure washers; pressure washing machines; component parts for high pressure washers and pressure washing machines and accessories in the nature of spray wands, nozzles, hoses, power-operated spray guns and fittings for high pressure washers and pressure washing machines

With regard to the partial refusal, the Examining Attorney states that the similarity or relatedness of the § 2(f) Refused Goods and the goods covered by Applicant's Prior Registrations (the "**Prior Registrations Goods**")<sup>1</sup> is not self-evident, and therefore Applicant's § 2(f) claim for the § 2(f) Refused Goods is not acceptable without additional information. Applicant disagrees that the relatedness between the § 2(f) Refused Goods and the Prior Registrations Goods is not self-evident.

However, in response to the Examiner's refusal to accept Applicant's § 2(f) claim in full, Applicant has provided evidence as discussed below which demonstrates that the § 2(f) Refused Goods are sufficiently similar or related to the Prior Registrations Goods to support acceptance of Applicant's § 2(f) claim in full, because (1) multiple third parties sell both the Prior

Registrations Goods and the § 2(f) Refused Goods under the same trademark, as shown by Internet evidence submitted by Applicant herewith, and (2) multiple third-party trademark registrations cover both the Prior Registrations Goods and the § 2(f) Refused Goods. Applicant therefore requests that the Examining Attorney accept the § 2(f) claim with regard to all of Applicant's Goods, and approve this application for publication without further delay.

## II. <u>Applicant's § 2(f) Claim Should Be Accepted in Full, as Applicant's § 2(f) Refused</u> Goods Are Sufficiently Similar or Related to Applicant's Prior Registrations Goods

#### A. Legal Standards for Establishing Acquired Distinctiveness

An intent-to-use applicant "who has used the mark on related goods or services may file a claim of acquired distinctiveness under § 2(f) before filing an allegation of use." TMEP § 1212.09(a). The claim of acquired distinctiveness should be accepted "if the applicant can establish that, as a result of the applicant's use of the mark on [the] other goods or services, the mark has become distinctive of the goods or services in the intent-to-use application, and that this previously created distinctiveness will transfer to the goods and services in the intent-to-use application when use in commerce begins." *Id.* (citing *In re Dial-A-Mattress Operating Corp.*, 240 F.3d 1341, 1347, 57 USPQ2d 1807, 1812 (Fed. Cir. 2001)).

As set forth in the TMEP, a § 1(b) applicant's "required showing" for establishing acquired distinctiveness is twofold: (1) "a showing of acquired distinctiveness of the same mark in connection with other goods and/or services"; and (2) "a sufficient relationship between the goods or services in connection with which the mark has acquired distinctiveness, and the goods or services recited in the intent-to-use application," thus warranting "the conclusion that the previously created distinctiveness will transfer" to the applicant's goods and services when use begins. TMEP § 1212.09(a) (quoting *In re Rogers*, 53 USPQ2d 1741, 1744 (TTAB 1999).

To satisfy the first requirement, an applicant "must establish acquired distinctiveness as to the other goods or services by appropriate evidence, such as ownership of an active prior registration for the same mark for sufficiently similar or related goods or services..." *Id.* Applicant has clearly satisfied this requirement with respect to the Prior Registrations Goods by virtue of its ownership of the Prior Registrations.

To satisfy the second requirement, an applicant "must show 'the extent to which the goods or services in the intent-to-use application are related to the goods or services in connection with which the mark is distinctive, and that there is a strong likelihood that the mark's established trademark function will transfer to the related goods or services when use in commerce occurs." *Id.* (quoting *Rogers*, 53 USPQ2d at 1745).

# B. Internet Evidence Shows That Multiple Third Parties Sell the Prior Registrations Goods and the § 2(f) Refused Goods Under the Same Mark

The relatedness between Applicant's Prior Registrations Goods and § 2(f) Refused Goods is established by the fact that each of them comprises types of outdoor power equipment that are typically sold under the same marks or brands and travel in the same or similar trade channels.

Specifically, chain saws, hedge trimmers, pressure washers and electrical generators are all motorized outdoor power equipment that are marketed and sold to homeowners and contractors through both big-box retail outlets such as The Home Depot or Lowe's as well as specialized power equipment dealers.

In support, Applicant has attached copies of Internet evidence showing that multiple third parties sell both the Prior Registrations Goods (chain saws, hedge trimmers, log splitters, etc.) and the § 2(f) Refused Goods (electric generators, pressure washers) under the same marks or brands. To wit:

- DeWalt sells chain saws, hedge trimmers, electric generators and pressure washers under the DEWALT brand;<sup>2</sup>
- Craftsman sells chain saws, hedge trimmers, log splitters, electric generators and pressure washers under the CRAFTSMAN brand;<sup>3</sup>
- Ryobi sells chain saws, electric generators and pressure washers under the RYOBI brand:<sup>4</sup>
- Echo sells chain saws, electric generators and pressure washers under the ECHO brand;<sup>5</sup>
- Stihl sells chain saws and pressure washers under the STIHL brand;<sup>6</sup> and

• The Home Depot sells chain saws and electric generators under the SPORTSMAN brand.<sup>7</sup>

The attached Internet evidence at Exhibits A-F clearly shows that consumers are accustomed to encountering and purchasing a variety of outdoor power equipment products – including chain saws and hedge trimmers as well as electric generators and pressure washers – under the same brands. Thus, this evidence clearly establishes the relatedness between Applicant's Prior Registrations Goods (chain saws, hedge trimmers, log splitters, etc.) and § 2(f) Refused Goods (electric generators, pressure washers).

# C. Multiple Third-Party Trademark Registrations Cover Both the Prior Registrations Goods and the § 2(f) Refused Goods

The relatedness of Applicant's Prior Registrations Goods and § 2(f) Refused Goods is further demonstrated by the existence of multiple registrations on the USPTO Principal Register which cover both Prior Registrations Goods (chain saws, hedge trimmers) and § 2(f) Refused Goods (electric generators, pressure washers). For example:<sup>8</sup>

- U.S. Reg. No. 5764013 for SENIX, covering "Power-operated blowers; electric generators, electricity generators; electric hedge shears; lawn mowers and trimmers; electric wood saw machines; string trimmers; cultivators; chainsaws and power-operated saws" in International Class 7;
- U.S. Reg. Nos. 5676122 for HERCRENTALS and Design and 5623693 for HERC RENTALS, covering "aerial equipment, namely, mechanical and hydraulic lifts; hoists; air compressors; power operated tools namely, drills, routers, tile saws; air operated tools, namely, impact wrenches, ratchet wrenches, drills, grinders, orbital sanders; impact wrenches, nutrunners, power operated ratchet wrenches, reciprocating saws, power operated breakers, power operated grinders, power operated rivet busters, power operated rock drills, power operated rock splitters, and power operated chipping hammers, ground surface finishing and compacting machines; concrete paving machines; concrete and masonry equipment, namely, concrete construction machines, finishing machines, and concrete vibrators; concrete cutting and drilling power tools, namely, core drills and rotary and hammer drills; concrete placing machines, namely, buggies, concrete vibrators, concrete mixers, mortar mixers, power-operated saws, screeds, and power-operated trowels; earth moving machines, namely, backhoes, loaders, bulldozers, excavators, and trenchers; machines for blast cleaning a surface, floor care and surface preparation for the purposes of cleaning and restoration, namely, carpet cleaning machines, floor cleaning machines; automatic floor scrubbers,

electric floor sweepers, vacuum cleaners, floor sanders, floor buffers, floor polishers, floor edgers, and floor nailing machines, power operated concrete grinders, power operated concrete planers, power operated floor strippers, power operated linoleum rollers, power operated road surface removal machines, namely, scabblers, scalers; and power operated sand blasting apparatus, namely, shot blasters; power-operated lifting and moving equipment, namely, winches, tuggers, conveyors, cranes, fork lifts, beam trolleys, hydraulic jacking cylinders, portable electric power generators, mechanical and hydraulic lifts, loading and unloading machines; power generators, namely, diesel and electric generators; power tools and machines, namely, plaining machines, boring tools, drilling tools, milling tools, turning tools; hand-held battery actuated hydraulic crimp tools; power lawn and garden tools, namely, chippers; shredders for industrial use, stump removal tools, namely, brush chippers and stump grinders; machines, namely, concrete and paving breakers for industrial and commercial applications; power-operated nailing guns; grinding and polishing machines; grinders, namely, right angle grinders and die grinders; hydraulic punching presses for metalworking; portable hydraulic pumps, power lawn and garden tools, namely, aerators; power operated bed edgers; power operated blowers; power operated brush cutters; chain saws; power operated hedge trimmers; power-operated lawn edgers; power machines for cutting and splitting logs; lawn mowers; power operated pole pruners; power operated post drivers; power operated posthole augers; power operated sod cutters; power operated straw blowers; power operated thatchers; *power operated tillers and weed cutters*; power operated magnetic drills; power-operated nailing guns; power staplers; power operated paint sprayers; power-operated plumbing snakes; electric sanders and finishers; power operated street sweepers; gas-powered drills; power operated right angle drills; power operated screw guns; welding equipment, namely, electric plasma cutters; electric arc welders and welding accessories, namely, welding electrodes and welding torches; electric welding rod ovens for the purpose of preventing moist rods and electrodes from drying out and producing weak welds; pump equipment, namely, centrifugal pumps, pump diaphragms, high pressure pumps for use in oil or gas well hydraulic fracturing operations; centrifugal pumps; pump diaphragms hydraulic power unit pumps; power operated industrial pumps as parts of oilfield wellhead machines; diesel industrial pumps namely, fuel dispensing pumps for land vehicles; submersible pumps; pumps for use with wastewater capable of passing debris and diesel well point pumps for extracting groundwater; vacuum cleaners for industrial purposes, namely, vacuum trailers for the purpose of industrial clean-up, suction and storing" in International Class

As shown by the Internet evidence and third-party registrations discussed above, it is clear that Applicant's Prior Registrations Goods and § 2(f) Refused Goods are closely related and typically sold under the same brands and through the same channels. Consumers are not only accustomed to encountering both types of goods from the same source, but have come to expect it. Accordingly, Applicant has met its burden of showing a close relationship between the Prior Registrations Goods and § 2(f) Refused Goods, sufficient to show that the previously-created distinctiveness for the Prior Registrations Goods will transfer to the § 2(f) Refused Goods upon use.

#### III. Conclusion

In view of the foregoing, Applicant has met its burden of demonstrating that Applicant's Mark is entitled to registration under § 2(f) as to all of Applicant's Goods, and thus the Examining Attorney should withdraw the § 2(e)(2) refusal and approve this application for publication.
