The following remarks are responsive to the Office action dated November 3, 2020 for U.S. Trademark Application No. 90053726.

**Application Signature**

Applicant hereby submits the following statement in order to correct the signature deficiency:

**Applicant has a bona fide intention to use the mark in commerce and had a bona fide intention to use the mark in commerce as of the application filing date; Applicant believes applicant is entitled to use the mark in commerce on or in connection with the goods or services specified in the application; Applicant believes applicant is the owner of the mark; to the best of the signatory's knowledge and belief, no other persons, except, if applicable, concurrent users, have the right to use the mark in commerce, either in the identical form or in such near resemblance as to be likely, when used on or in connection with the goods/services of such other persons, to cause confusion or mistake, or to deceive; the facts set forth in the application are true. 37 C.F.R. §§2.33(b), (c), 2.34(a)(1)(i), (a)(2), (a)(3)(i), (a)(4)(ii), 2.59(a).**

**Identification of Services**

Applicant hereby amends the services description as shown below:

International Class 036: Financial services, namely, **providing** a virtual currency **for use by members of an on-line community** capable of being transferred between users via a blockchain operating on a global peer-to-peer network

International Class 042: Design and development of computer software for peer-to-peer networks using blockchain technology; ~~a~~**D**eveloping and updating of computer software for use in managing crypto-currency and block chain data; ~~a~~**A**pplication service provider featuring application programming interface (API) software for providing a platform for the development, testing, and integration of blockchain software applications; **Computer services, namely,** acting as an application service provider in the field of information management to host computer application software for the purpose of developing, testing, and integrating blockchain applications and software

### **Meaning/Significance**

Applicant respectfully submits the term “code” is used within the general field of computer programming to refer to computer executable instructions (e.g., software) that can be defined using computer languages. The act of providing virtual currency via a blockchain operating on a network relies on software executed by computers. Applicant is unaware of any significance of the term “code” within the field of financial services or virtual currency beyond its use within the general field of computer programming.

### **Suspension**

Applicant notes that Canadian Application No. 2006278, to which the U.S. application claims priority, has not yet registered. Applicant requests that the U.S. application remain suspended pending the issuance of the Canadian Registration.
