RESPONSE TO OFFICE ACTION

This correspondence is being sent in response to an Office Action dated September 19, 2021 (the "Office Action") with regard to Chums, Inc's ("Applicant") application to register its CHUMS and (Booby Bird Design) trademark ("Applicant's Mark"). The Examining Attorney refused registration of Applicant's Mark on the grounds that Applicant's Mark is merely a decorative or ornamental feature of the goods with respect to the goods in Classes 16 and 21. Applicant respectfully disagrees and believes that the specimen serves a secondary source-indicating function for the reasons set forth below.

I. USE OF APPLICANT'S MARK IS NOT ORNAMENTAL

Applicant respectfully submits that (a) Applicant's Mark already serves as an indicator of source for other goods and services and (b) Applicant's Mark has acquired distinctiveness under Trademark Act Section 2(f) for the Class 16 and 21 goods in the present application ("Applicant's Goods"). For these reasons, Applicant respectfully requests that the Examining Attorney withdraw the refusal to register Applicant's Mark.

a. Applicable Law

"Matter which serves as part of the aesthetic ornamentation of goods such as T-shirts may nevertheless be registered if it also serves a source-indicating function. Such ornamental matter may be found to additionally serve a source-indicating function, and hence to be registrable, if, for example, it names the secondary source of the goods or if, at the time of its first use as ornamentation, it was already a recognized trademark of applicant for services or other goods." In Re Astro-Gods Inc., 223 U.S.P.Q. 621 (TTAB 1984) (citing In re Olin Corp., 181 USPQ 182 (TTAB 1973); In re Paramount Pictures Corp., 213 USPQ 1111 (TTAB 1982), and cases cited therein; and In re Paramount Pictures Corp., 217 USPQ 292 (TTAB 1983)). Just because a "mark" is visually pleasing or serves in some way to ornament the goods does not render it unregistrable if the mark is also inherently distinctive, In re: Swift & Co., 223 F.2d 950, 106 USPQ 286, 288 (CCPA 1955), or if it has acquired distinctiveness. "[W]hile not every sign used on a product, or on its label, package, etc., functions as an indication of source of the product on which it is used – e.g. some are merely part of the aesthetic ornamentation – the broad and liberal interpretation of our law is that, where such a sign also serves a source indicating function, it should be regarded as acceptable subject matter for registration." In Re Tire Mart, Inc., Ser. No. 78292388, 2008 WL 853804, at *2 (Jan. 22, 2008) (quoting *In re Paramount Pictures Corp.*, 213 USPQ 1111, 1113 (TTAB 1982)).

b. Applicant's Mark Already Serves as an Indicator of Source for Other Goods or Services, and Has Acquired Distinctiveness for Applicant's Goods.

Applicant respectfully submits that Applicant's Mark is already perceived by consumers as a source indicator based on Applicant's prominent use of Applicant's Mark with various goods and services for nearly 40 years. See, e.g., Attachment A (printout from https://chums.com/pages/about-chums).

Applicant is a retailer of outdoor products and accessories, which are sold online and in retail locations throughout the United States (and the world). Applicant's goods include, among other things, clothing (e.g., jackets, sweatshirts, shirts, T-shirts, pants, shorts, hats and sweatpants), cases for personal electronic devices, cases for eyeglasses and sunglasses, all purpose carrying bags, athletic bags, handbags, belt bags, hip bags, bum bags, hiking bags, key bags, clutch bags,

shoulder bags, tote bags, bags for eyeglasses and sunglasses, felt pouches, drawstring pouches, purses, clutch purses, wallets, card wallets, key wallets, pocket wallets, satchels, business card cases, calling card cases, credit card cases, key cases, carrying cases, pocketbooks, eye glass retainers, sunglass cases, glove clips, keychains, safety accessories, and lanyards. See Attachment B (pictures provided as specimens for Reg. Nos. 2,432,635, 4,094,382, and 4,277,154).

Applicant has also used Applicant's Mark to brand its website for more than 20 years. See, e.g., Attachments C (printout from

https://web.archive.org/web/19980419150707/http://chums.com/ (April 19, 1998)), D (printout from https://web.archive.org/web/20100131001217/http://www.chums.com/ (January 31, 2010)), and E (https://www.chumssafety.com/ (March 10, 2022).

For example, Applicant has promoted and sold Applicant's Goods online on Applicant's website, and at retail locations on Applicant's website. Applicant has also made considerable efforts to educate consumers and to develop its brand so as to associate the
