RESPONSE TO OFFICE ACTION

Dear Commissioner:

This is in response to an Office Action dated November 4, 2021 for the mark M MOBI & Design, U.S. Serial No. 90678746 ("Applicant's Mark"). In this response, Applicant responds to the citation to MOBIWEB, U.S. Reg. No. 6407948, and MOBIWEB MAKING THE WORLD SEEM SMALLER! & Design, U.S. Reg. No. 6407949, for "Providing Internet access; communication by computer terminals; Internet service provider services; providing voice chat services; providing on-line chat rooms for social networking; telephone voice messaging services; instant messaging services; provision of voice short message services (VSMS); wireless telephone telecommunications services, namely, wireless mobile telephone calling plans; telecommunications reseller services for businesses, namely, providing long distance telecommunication services, voice telecommunication services, local telephone service,

and Internet access services," owned by Mobiweb Telecom Limited (the "Cited Registrations") as a bar to registration of Applicant's Mark for "Wireless telephone telecommunications services, namely, wireless mobile telephone calling plans."

REMARKS

I. Petition for Cancellation

On April 29, 2022, Applicant filed a Petition for Cancellation against the Cited Registrations, based on Applicant's use of Applicant's Mark prior to the date of first use set forth in the Cited Registrations, and the fact that Mobiweb Technologies Limited had not used the Cited Registrations in connection with certain goods and services listed in the Cited Registrations prior to filing its applications (the "Cancellation Proceeding").¹ Accordingly, Applicant respectfully requests that the Examining Attorney suspend further action on the Application until the termination of the Cancellation Proceeding. *See* TMEP § 716.02(a).

In the alternative, Applicant respectfully submits that there is no likelihood of confusion between Applicant's Mark and the Cited Registrations, and accordingly Applicant's Mark should be approved for publication.

II. No Likelihood of Confusion

The Examining Attorney has initially refused registration of Applicant's Mark on grounds that it is likely to be confused with the Cited Registrations. Applicant respectfully submits that, upon consideration of the relevant likelihood of confusion factors, there is no likelihood of confusion between Applicant's Mark and the Cited

Registrations. Factors negating any likelihood of confusion here include (i) the different commercial impressions conveyed by Applicant's Mark and the Cited Registrations, (ii) the coexistence of other federally registered marks that bear greater similarity than the Applicant's Mark to the Cited Registration, (iii) the differences in the respective channels of trade, (iv) the sophistication of the relevant consumers, and (v) the absence of any evidence of actual confusion. See, e.g., E. I. Du Pont DeNemours & Co., 476 F.2d 1357 (C.C.P.A. 1973) (enumerating likelihood-of-confusion factors).

A. The Commercial Impression of the Parties' Marks Differ

Applicant respectfully submits that the Examining Attorney was incorrect in determining that the Applicant's Mark and the Cited Registrations are confusingly similar in terms of commercial impression, and in particular that the Examining Attorney did not appropriately factor in the inclusion of the term "web" in the Cited Registrations.

While both Applicant's Mark and the Cited Registrations contain the term "Mobi," which suggests a connection to mobile telephone services, the inclusion of the suffix "web" in the Cited Registrations conveys an additional association with the internet (which association is absent from Applicant's Mark). Thus, whereas the commercial impression conveyed by Applicant's Mark focuses exclusively on mobile phone services, the commercial impression conveyed by the Cited Registrations suggests a connection with *both* mobile phone services and the internet.

This difference in commercial impression is reinforced by the actual services offered by the parties—Applicant provides traditional mobile phone telecommunication services (*see, e.g.,* <https://mobi.com/about/>), whereas the Cited Registrations are used primarily in connection with SMS text messaging services, including the provision of

"virtual" mobile numbers using internet functionality. *See, e.g.,* <https://www.solutions4mobiles.com/products/2-way-sms>.

In sum, the important addition of "web" to the Cited Registrations entirely changes their meaning and creates a distinct commercial impression, dissimilar to that created by Applicant's Mark. *See Tricia Guild Assocs. LTD*, 38 U.S.P.Q.2d at 1316 ("[W]hile the marks DESIGNERS GUILD and THE DESIGN GUILD share similarities which are too obvious to discuss, nevertheless, the differences, however slight, are sufficient to 'convey different connotations and commercial impressions.'").

Similarly, different numbers of syllables in the relevant marks militates in favor of a finding of no likelihood of confusion. *See, e.g., StonCor Grp., Inc. v. Specialty Coatings, Inc.*, 759 F.3d 1327, 1332 (Fed. Cir. 2014) (stating that the "differing number of syllables in the two complete marks" supported the finding that no likelihood of confusion existed). Here, Applicant's Mark contains only two syllables, whereas the Cited Registrations contain three syllables each, thus further counseling against a finding of confusion. Finally, the design element of Applicant's Mark further separates and distinguishes it from the Cited Registrations, making confusion even less likely.

B. The Cited Registrations are Entitled to a Narrow Scope of Protection

Applicant submits that the Cited Registrations have coexisted on the Principal Register with other third-party registrations and applications that in some way arguably relate to the telecommunications industry or related fields that include the term "Mobi," evidencing that the Cited Registrations are diluted and entitled to only a narrow scope of protection. These coexisting federal registrations include:

The numerous third-party marks in other telecommunication and computer software classes, as well as other related fields, containing the term "Mobi" are relevant to show that the Cited Registrations are "relatively weak and entitled to only a narrow

scope of protection," and would not be confused with different marks, such as the Applicant's Mark. Palm Bay Imports, Inc. v. Veuve Clicquot Ponsardin Maison Fondee En 1772, 396 F.3d 1369, 1373 (Fed. Cir. 2005); see also Standard Brands Inc. v. Peters, 191 U.S.P.Q. 168, 172 (T.T.A.B. 1976) ("the limited orbit of protection to be afforded (trademarked) term is clearly revealed by third-party registrations").

C. The Respective Channels of Trade Differ Significantly

The SMS-focused, enterprise solution services offered under the Cited Registrations are marketed toward business. *See, e.g.*, <https://www.solutions4mobiles.com/>. In fact, all services offered by Mobiweb Technologies Limited, the owner of the Cited Registrations, are intended for use by businesses or other enterprise customers. *See id.* Applicant's services, by contrast, are marketed specifically toward individual mobile phone users. There is no likelihood that a customer seeking to purchase a suite of enterprise solutions for communicating with a business's customers—primarily by SMS messaging—would be confused into contacting Applicant's wireless company. Similarly, there is no likelihood that an individual seeking a new personal cellphone plan would contact Mobiweb Technologies Limited, which does not offer any services for individual customers, nor any traditional mobile telecommunication services at all.

D. Sophistication of Customers Obviates Likelihood of Confusion

Applicant submits that consumers will readily understand the distinction between Applicant's Mark and the Cited Registrations, and the services offered thereunder. The consumers of the enterprise solutions offered under the Cited Registrations apparently must undertake an extensive process of registering an account and discussing their needs with Mobiweb Technologies Limited prior to receiving any information on pricing or

plans. See <http://sms.solutions4mobiles.com/accounts/register.php?cta=>. Such consumers are likely to be sophisticated and cost-conscious, and conduct substantial research before investing in a service for their business. As such, it is highly unlikely that such a sophisticated consumer, spending significant amounts of time and money on the services offered under the Cited Registrations, would be misled into thinking that Applicant's Mark is related to the Cited Registrations. Similarly, it is highly unlikely that any of Applicant's customers, who are looking for simple and affordable mobile phone plans would be confused into believing that Mobiweb Technologies Limited's enterprise services or the Cited Registrations were related to Applicant's services or Applicant's Mark.

E. Absence of Actual Confusion

Applicant submits that confusion is not likely here, as Applicant has been using Applicant's Mark since at least as early as 2018 (and has been using the mark MOBI since at least as early as 2006), and is unaware of any actual confusion between Applicant's Mark and the Cited Registrations. Accordingly, given that the marks have coexisted in the market for at least 18 months without any instances of actual confusion, Applicant submits that any future confusion is not likely.

For all the foregoing reasons, there is no likelihood of confusion between Applicant's Mark and the Cited Mark.

CONCLUSION

In light of the above remarks, Applicant respectfully requests that the
Examining Attorney approve Applicant's Mark for publication.

4. The U.S. Patent And Trademark Office Examining Attorney who has reviewed the Applications has refused to publish the Applications for opposition and has cited Registration Nos. 6407948 and 6407949 as the basis for such refusal.

Petitioner's Priority in the Marks

5. The Registrations list October 3, 2020 as the first use in commerce date. Attached hereto as Exhibit B is a true and correct printout from the United States Patent And Trademark Office Trademark Status & Document Retrieval (TSDR) reflecting the Registrations.

6. This first use date postdates Petitioner's first use in commerce, including as reflected in the Hawai'i Registration, by at least 2 years. Attached hereto as Exhibit C is a true and correct copy of the Hawai'i Registration.

7. Accordingly, to the extent there is a likelihood of confusion between the Registrations and Petitioner's marks as reflected in the Applications, Petitioner has priority, and the Registrations are subject to cancellation pursuant to 15 U.S.C. §§ 1052(d) and 1064(1).

Registrant's Non-Use of Mark In Commerce Before Application

8. The Registrations claim that the Registrants' mark was purportedly used in connection with, *inter alia*: (i) "Providing Internet access;" (ii) "Internet service provider services;" and (iii) "wireless telephone telecommunications services, namely, wireless mobile telephone calling plans" prior to the filing date. *See* Exhibit B.

9. Upon information and belief, Registrant did not use the marks covered by the Registrations in U.S. commerce, or any similar mark, in connection with such goods or services prior to filing for the Registrations, nor does Registrant use the marks covered by the Registrations in U.S. commerce in connection with such goods or services currently.

10. Accordingly, the Registrations are void *ab initio* and are subject to cancellation pursuant to 15 U.S.C. §§ 1051(a)-(d) and 1064(1).

Injury to Petitioner

11. Petitioner is and will continue to be injured and damaged by the existence of the Registrations because it is preventing Petitioner's Applications from proceeding to registration. Petitioner therefore has a real interest in seeking cancellation of the Registrations and standing to bring this action.

Relief Requested

WHEREFORE, Petitioner requests that the Registrations be cancelled in their entirety and that this Petition For Cancellation be sustained in favor of Petitioner.

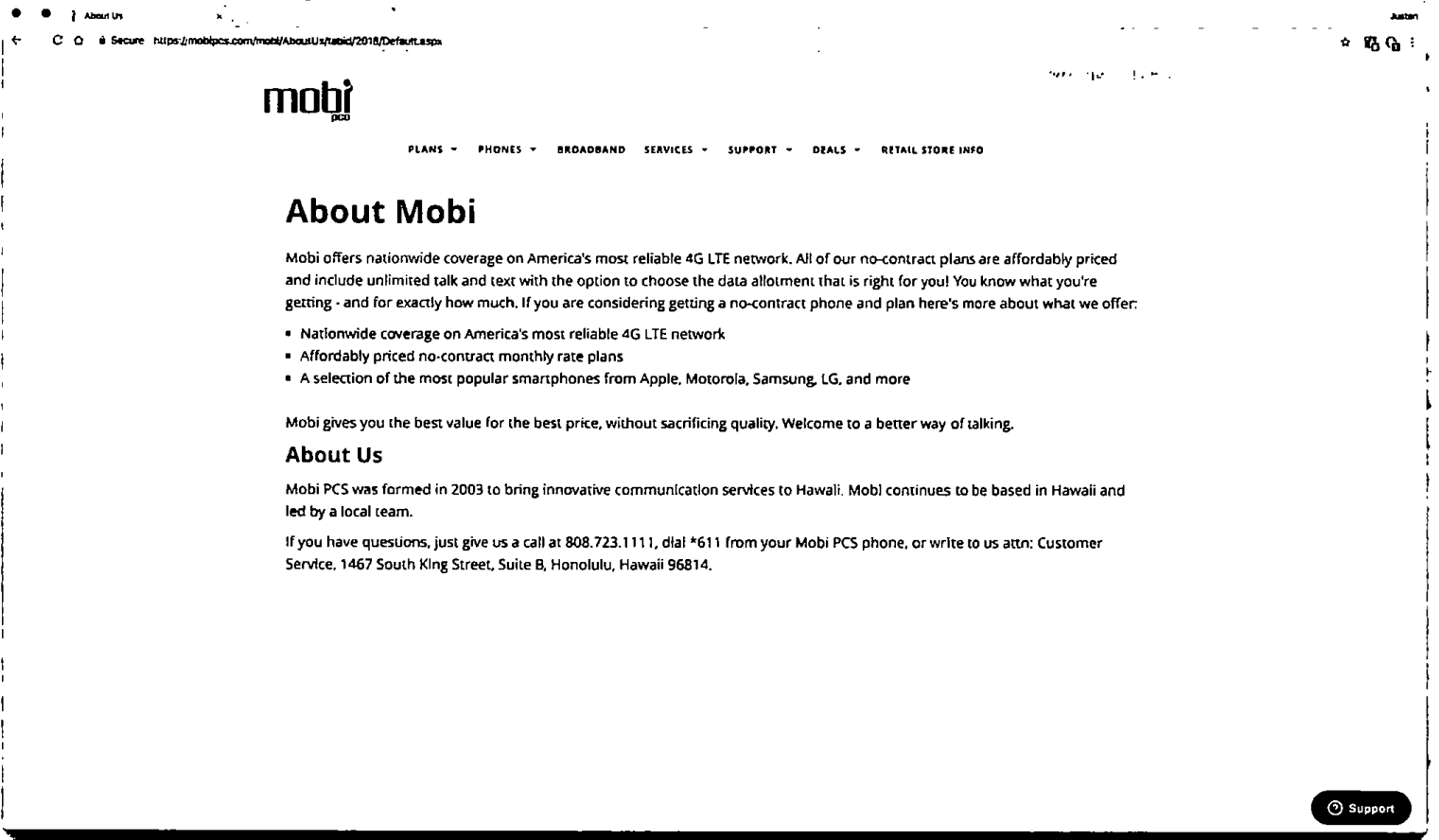
