CONSENT TO TRADEMARK REGISTRATION

This Consent to Trademark Registration is entered into by and between Lafco Enterprises Inc. ("Lafco"), a corporation organized under the laws of New York with an address at 285 Lafayette Street, New York, New York 10012 and Byredo AB ("Byredo"), a Limited Company organized under the laws of Sweden with an address at Mäster Samuelsgatan 42 SE-111 57 Stockholm, Sweden, collectively "the Parties."

WHEREAS, Lafco has applied to register the mark LIBRARY with the U.S. Patent and Trademark Office ("USPTO") under Serial No. 86331284 ("the Application") for the goods stated therein ("Lafco's Goods");

WHEREAS, the Application has been refused based on the citation U.S. Registration No. 4243997 (the "Registration") covering the mark BIBLIOTHÈQUE for the goods listed therein ("Byredo's Goods");

WHEREAS, the Parties have concluded that confusion is not likely to arise from their respective use and registration of their different marks;

NOW, in consideration of the mutual promises included below, and for such other good and valuable consideration, receipt of which is hereby acknowledged, it is agreed as follows:

1. Byredo consents to the use and registration of Lafco's LIBRARY mark in connection with Lafco's Goods and to submission of this Consent Agreement to any court or administrative tribunal as well as to the USPTO.
2. Lafco consents to the use and registration of Byredo's BIBLIOTHÈQUE mark in connection with Byredo's Goods.

3. The Parties agree, in good faith, to take all reasonable steps to avoid confusion in the market between their respective marks. The Parties further agree, in good faith, to take all reasonable and proper steps to eliminate any confusion in the marketplace, should either party hear of such confusion.

4. This Agreement is binding on all successors, assigns (including successors in ownership or assigns of the marks at issue) parents, licensees, subsidiaries, entities owned or controlled by a Party, or in which a Party is a partner, affiliates, and divisions of the Parties.

5. This Agreement may be executed in counterparts and by way of fax or scanned signature.

6. The effective date of this Agreement is the last date identified below.
