The following remarks are in response to the Suspension Notice issued on December 4, 2019.

**I. Suspension and Refusal Based on Serial No. 88042903**

Applicant respectfully disagrees with Examiner's suspension of Applicant's application due to the pending application for OFFICE SADDLE BAG (SN: 88042903) (the "Pending Mark"). As stated in Applicant's office action response filed on December 3, 2019, Applicant's Mark no longer conflicts with the Pending Mark.

See below chart and Exhibit A for TSDR records for evidence of third-party registrations for bag marks that contain the shared, and therefore weak, term OFFICE:

The Pending Mark is for use in connection with “tote bags” in Class 18. Applicant’s Mark is for use in connection with “Purses; wallets; umbrellas; travel cases; coin, credit card, business card, membership and loyalty card, banknote, label, ticket, document, and key holders; garment carriers, baby carrying bags, and animal carriers; carry-all and all-purpose carrying bags; handbags; parasols; ***all of the foregoing excluding tote bags***” in Class 18 (“Applicant’s Goods”). The Pending Mark and Applicant’s Mark do not identify the same goods.

The TTAB ruled that there is no *per se* rule that all apparel (and by extension accessories, like bags) is related. See *In Re British Bulldog, Ltd.*, 224 U.S.P.Q. 854 (T.T.A.B. Nov. 1, 1984). A deeper analysis is required to determine if the Pending Mark’s tote bags are in fact so closely related to Applicant’s Goods that a likelihood of confusion exists.

The existence of third-party registrations for similar marks can show goods are distinct enough for marks to coexist peacefully. See above chart and Exhibit A. In *In Re Thor Tech, Inc.*, 113 U.S.P.Q.2d 1546 (T.T.A.B. 2015), the Board reversed the refusal to register TERRAIN for towable trailers in light of the mark TERRAIN for trucks because evidence of third-party registrations can weigh ***against*** a finding of similar goods and ***against*** a finding of likelihood of confusion, even when marks are identical and the goods are complementary or similar. Three registered marks include the term “OFFICE” for bags. This evidence weighs against a likelihood of confusion in this case, where

the goods are not the same, and further illustrates that Applicant's Mark can peacefully coexist with the Pending Mark.

Also, as stated in the Office Action response filed on December 3, 2019, the Pending Mark already co-exists with several registrations for marks incorporating OFFICE for Class 18 bags and is thus very weak. See above chart and Exhibit A. Evidence of widespread third-party use of common elements of marks can make confusion very unlikely. *In Re Broadway Chicken Inc.*, the Board reversed a refusal to register the mark BROADWAY CHICKEN for restaurant services due to BROADWAY PIZZA and BROADWAY BAR marks peacefully coexisting for restaurant services. "Evidence of widespread third-party use, in a particular field, of marks containing a certain shared term is competent to suggest that purchasers have been conditioned to look to the other elements of the marks as a means of distinguishing the source of goods or services in the field." *In Re Broadway Chicken Inc.*, 38 U.S.P.Q.2d 1559 (T.T.A.B. 1996). The term "OFFICE" as used in Applicant's Mark and the Pending Mark, which are not the same mark, can peacefully coexist because evidence of widespread third-party use suggests that purchasers are able to distinguish the various sources of goods. The third-party marks in the above chart also show that the purchasing public are able to recognize minute distinctions between marks. See *Juice Generation, Inc. v. GS Enterprises LLC*, 794 F.3d 1334 (Fed. Cir. 2015); *In re FabFitFun, Inc.*, 127 U.S.P.Q.2d 1670, 2018 WL 4043156, at \*4 (T.T.A.B. 2018). The Pending Mark contains words not included in Applicant's Mark and they distinguish the marks enough to avoid confusion. TMEP § 1207.01(b)(iii) ("Additions . . . to marks may be sufficient to avoid a likelihood of confusion if . . . the matter common to the marks is not likely to be perceived by purchasers as distinguishing source because it is . . . diluted."); TMEP § 1207.01(b)(viii) ("If the common element of two marks is 'weak' . . . it is unlikely that consumers will be confused unless the overall combinations have other commonality"); TMEP § 1207.01(d)(x) ("[i]f the examining attorney finds registrations that appear to be owned by more than one registrant, he or she should consider the extent to which dilution may indicate that there is no likelihood of

confusion”); *McCarthy on Trademarks and Unfair Competition* § 23:48 (“Whether a mark is classified as ‘strong’ or ‘weak’ is a very important element in deciding likelihood of confusion. If the common element of conflicting marks is a word that is ‘weak’ then this reduces the likelihood of confusion. A portion of a mark may be ‘weak’ in the sense that such portion . . . is in common use by many other sellers in the market.”); *Palm Bay Imports, Inc. v. Veuve Clicquot Ponsardin Maison Fondee en 1772*, 73 USPQ2d 1689, 1693 (Fed. Cir. 2005) (“If the evidence establishes that the consuming public is exposed to third-party use of similar marks on similar goods, this evidence ‘is relevant to show that a mark is relatively weak and entitled to only a narrow scope of protection.’”). Therefore, Applicant’s Mark can also safely co-exist with the Pending Mark for bags without causing a likelihood of consumer confusion.

Applicant respectfully requests Examining Attorney withdraw the potential refusal to register based on the Pending Mark and allow the Mark to register.

## **II. Section 2(d) Refusal – Likelihood of Confusion Maintained and Continued**

### **a. Refusal Based on Registration No. 5160973**

The Examining Attorney stated in her June 26, 2019 Office Action, “both applicant and the registrant for OFFICE PAL offer spectacles and sunglasses.” With Applicant’s response dated December 3, 2019, Applicant deleted “sunglasses” and “spectacles.” Now that there is no overlap in goods, Applicant respectfully asks the Examining Attorney to withdraw the refusal.

### **b. Refusal Based on Registration No. 2080325**

The Examining Attorney stated in her June 26, 2019 Office Action, “both applicant and the registrant for OFFICE ON WHEELS offer luggage.” With Applicant’s response dated December 3, 2019, Applicant deleted “luggage.” Now that there is no overlap in goods, Applicant respectfully asks the Examining Attorney to withdraw the refusal.

**c. Refusal Based on Registration No. 4709071**

The Examining Attorney stated in her June 26, 2019 Office Action “the application uses broad wording to describe ‘pouches’, which presumably encompasses all goods of the type described, including the registered mark OFFICE WARRIOR’s narrower ‘fabric pouches sold empty that may be used to hold office supplies and equipment.’” With Applicant’s response dated December 3, 2019, Applicant deleted “pouches.” Now that there is no overlap in goods, Applicant respectfully asks the Examining Attorney to withdraw the refusal. For the above reasons, Applicant respectfully requests that the Examining Attorney lift the suspension, withdraw all refusals, and approve Applicant’s Mark for publication.
